Organisational Environment

Airservices is a government owned organisation providing safe, secure, efficient and environmentally responsible services to the aviation industry.

Each year we manage over four million aircraft movements carrying more than 156 million passengers, and provide air navigation services across 11 per cent of the world's airspace.

Airservices has two major operating centres in Melbourne and Brisbane and a corporate office in Canberra. We operate 29 air traffic towers at international and regional airports, and provide aviation rescue fire fighting services at 26 Australian airports.

Primary Purpose of Position

As the **Commercial Analyst** within the Procurement and Commercial Services team, you will support your primary business stakeholders to deliver the strategic vision and direction of sourcing and contract management.

You will provide a proactive, thorough, consistent and responsive approach in analysing commercial and category data to support the achievement of value for money. You will also be able to demonstrate strong communication and stakeholder engagement skills, particularly in guiding and supporting cross-functional teams.

Accountabilities and Responsibilities

Performance, Analytics and Reporting

- Analyse a range of data sources, to support the identification of trends and opportunities in a category and contract management context.
- Monitor the spend trend and perform analysis on data from various sources to identify the improvement opportunities or potential issues.
- Support procurement processes by providing data analytics into market trends, spend and asset information and assisting in the development of supporting procurement material including the use of internal, market and supplier analysis.

- Manage transactional procurement processes from time to time, as required by the Sourcing Lead.
- Support business stakeholders in undertaking procurement, purchasing and contract management activities through Airservices' procure to pay system, SAP Ariba.
- Provide reporting on procurement performance including gathering and presenting data on functional KPIs,
- Provide analytical support to Portfolio and Category/Commercial Managers in go-to-market activities and continuous improvement projects including spend analysis, savings calculation, should cost analysis and management presentations.

Tools and Frameworks

- Develop spend and contract frameworks addressing the integrity of Airservices' procurementrelated data from all relevant sources.
- Assist in the development of regular procurement, category and contract management reporting through the development and deployment of dashboards for spend, contracts, contract expiry and similar.
- Develop tools, templates and training to support procurement practitioner-led analytical activities.

People, Capability and Development

- Maintain an effective working relationship with other Airservices staff to ensure that there is effective coordination of all activities in support of organisational objectives
