ROLE CONTEXT

Primary Objective(s) of role:

- > The Dietician Clinical Lead is operationally responsible to the Senior Manager Children and Families Service for the development, implementation, coordination and evaluation of quality childhood dietetic and nutrition services for patients of the Northern Adelaide Local Health Network (NALHN).
- > Working in conjunction with other Children and Families team members and other relevant health professionals, the Dietician Clinical Lead optimises patient functional and health outcomes in this specialty area. As a highly skilled and competent clinician, the incumbent delivers quality services and provides clinical leadership within the allied health community teams, providing support and supervision to less experienced staff.

Key Relationships/ Interactions:

- > Reports to the Senior Manager Children and Families Service with regard to operational issues and to the Senior Manager of Dietetics and Nutrition for professional issues.
- > Works collaboratively with other members of their discipline and of inter-disciplinary teams.
- > Liaises with other health professionals, service providers and the community.
- > Responsible for the training and supervision of other health professionals and students as required.

- > Criminal and Relevant History Screening must be renewed every 5 years thereafter from date of issue for 'Prescribed Positions' under the *Child Safety (Prohibited Person) Act (2016)*.
- > Criminal and Relevant History Screening must be renewed every 3 years for 'Approved Aged Care Provider Positions' as defined under the Accountability Principles 2014 pursuant to the Aged Care Act 2007 (Cth).
- > Depending on work requirements the incumbent may be transferred to other locations across SA Health to perform work appropriate to classification, skills and capabilities either on a permanent or temporary basis subject to relevant provisions of the Public Sector Act 2009 for Public Sector employees or the SA Health (Health Care Act) Human Resources Manual for Health Care Act employees.
- > The incumbent may be required to participate in Counter Disaster activities including attendance, as required, at training programs and exercises to develop the necessary skills required to participate in responses in the event of a disaster and/or major incident.
- > May be required to work within other locations of the Northern Adelaide LHN.
