- Provide timely reports and advice on project delivery to project stakeholders, identify environmental risks and resolve issues which may impact successful project completion.
- Build strong relationship with key stakeholders to ensure positive environmental outcomes are achieved.
- Network with Federal, State and Local Government authorities to identify and implement environmental project and programs to meet Council's business needs.
