In 2013 ACU developed a research intensification strategy designed to achieve excellence in a selected number of areas of strategic priority. These areas include theology and philosophy. The outcome has been a remarkable transformation in the research standing of the University. In the 2019 THE World University Rankings, ACU has risen to the 401-500 band for research and specifically to the 201-300 band in the Arts and Humanities subject rankings which includes Philosophy. Our investment in philosophy is also designed to achieve a top rating of 5 in the assessment of research quality conducted by the Australian Research Council and known in Australia as the ERA (Excellence in Research for Australia). In 2019, of the Universities who were assessed in philosophy, only five institutions achieved the top rating of 5. Six Universities, including ACU were awarded a rating of 4 and the rest were rated 3 or below.

ABOUT THE INSTITUTE FOR PHILOSOPHY

Under the Directorship of Professor Stephen Finlay, the recently-established Institute for Philosophy will develop ACU's expertise in epistemology, ethics, metaphysics, political philosophy, social and political philosophy, philosophy of science, logic, aesthetics, history of philosophy, and philosophy of religion, thereby establishing a strong philosophy program in the Anglo-American tradition.

There are seven full-time research-focussed analytic philosophers at ACU in Melbourne: Nevin Climenhaga, Stephanie Collins, Stephen Finlay, David Killoren, Ole Koksvik, Tyler Paytas, Richard Rowland. An eight full-time philosopher, Samuel Baron, will join in late 2019. We also have several professorial fellows, who visit Melbourne for between several week and three months every year: Mark Alfano (Delft), Robert Audi (Notre Dame), Roger Crisp (Oxford), Stephen Evans (Baylor), and Eleanor Stump (St Louis). Professor Tony Coady is also an honorary member of staff at ACU Melbourne and participates regularly in research activity at the Melbourne campus. The research-focused philosophy program in Melbourne is tied to the broader philosophy program at the ACU which runs across all ACU's Australian campuses.

The Institute is in an exciting growth stage: all its appointments have been made in the previous three years and the institute is seeking to appoint 4 more full-time continuing research fellows. We seek to develop large-scale collaborative projects focused on philosophical problems in the near term. In addition, the Institute has developed and is developing strong international partnerships with the Philosophy faculties at leading Universities in Europe and North American such as the University of Oxford and the University of Southern California.

The Institute has an international outlook, seeks a diverse staffing profile, and welcomes applications from all suitably-qualified scholars. The area of specialization for this position is open.

Philosophy at ACU runs many events every year. Each year philosophers from the Melbourne campus run a workshop at ACU's campus in Rome, Italy. Robert Audi also runs a global issues in ethics conference at ACU's Rome campus every year. Many events are run in Melbourne too. In 2017 the program ran workshops on normativity, animal ethics, trust, and egoism and altruism. In 2018 the program ran a three-day international conference on moral epistemology as well as a workshop on acts and omissions and co-ran a weekly applied philosophy seminar with the University of Melbourne. In 2019 the program is already set to run a weekly work in



progress seminar as well as a two-day workshop on probability and a joint three-day conference on Utilitarian Approaches to Animal Ethics with the University of Oxford.
