You will be responsible to provide research services to project leaders and contribute to outputs in accordance with contracted requirements.

You will contribute to the delivery of environmental economics components within the project "Project-level environmental economic accounting for coastal blue carbon ecosystems". This project is a multidisciplinary project being led by Deakin University, and funded by the <u>Australian Department of Climate Change, Energy, the environment and Water</u> (previously Department of Agriculture Water and the Environment).

You will be working with Associate Professor Michael Burton and Dr Abbie Rogers, as well as collaborating with scientists, social scientists, accounting experts and wetland restoration managers nationally.

The position will include opportunities to actively engage and build networks with the academic community, environmental managers, government, private sector and NGOs both locally and nationally.
