# **POSITION PURPOSE**

The Senior Lecturer, (Level C) is expected to make significant contributions to teaching and research across the courses of study delivered by Monash Nursing and Midwifery (MNM). The role requires the incumbent to be a strong member of a committed team of academics within MNM. The incumbent will play a role in scholarship and research including Indigenous health and wellbeing and will contribute to MNM through both professional and administrative activities and engagement with key internal and external stakeholders.

It is recognised that an Indigenous nurse or midwifery academic will engage in their area/s of interest and will clearly influence the Indigenous content and research agenda within the School. There is opportunity to work in partnership with the Gukwonderuk Indigenous Health Unit, located within the Faculty to extend Indigenous understanding across the Faculty.

# **KEY RESPONSIBILITIES**

Specific duties required of a Level C academic may include:

- 1. The development, preparation and delivery of curriculum / programs of study within the nursing and midwifery pre and post registration programs, within the incumbent's areas of expertise and clinical practice
- 2. Provide leadership and contribute to strategic planning and operational aspects of the education programs in Monash Nursing and Midwifery
- 3. Unit co-ordination and course co-ordination within the incumbent's areas of expertise and clinical practice
- 4. Supervision of honours, postgraduate and higher degrees students
- 5. Promote and maintain high-quality research outputs, and demonstrate an active publication record
- 6. Significant role in research projects including, where appropriate, leadership of a research team
- 7. Mentorship of more junior academic staff
- 8. Engagement in professional activity
- 9. Broad administrative functions
- 10. Attendance at departmental, school and/or faculty meetings and a major role in planning or committee work

# **KEY SELECTION CRITERIA**

### **Education/Qualifications**

- **1.** The appointee will have:
  - A doctoral or masters qualification in the relevant discipline area or equivalent accreditation and standing and/or recognised significant experience in the relevant discipline area

A Level C academic will normally have advanced qualifications and/or recognised significant experience in the relevant discipline area. A position at this level will normally require a doctoral qualification or equivalent accreditation and standing.

In determining experience relative to qualifications, regard shall be had to teaching experience, experience in research, experience outside tertiary education, creative achievement, professional contributions and/or contributions to technical achievement. In addition, a position at this level will normally require a record of demonstrable scholarly and professional achievement in the relevant discipline area.

#### **Knowledge and Skills**

- 2. Demonstrated track record of practice, education and/or research specifically related to Indigenous issues
- **3.** Demonstrated track record of excellence in the development and delivery of nursing and/or midwifery units and programs of study in a higher education environment
- Demonstrated track record of strong clinical practice in nursing and/or midwifery and evidence of clinical experience informing and strengthening the incumbent's teaching and delivery of excellent education outcomes
- 5. Excellent interpersonal and communication skills and an ability to work independently and as part of a team are a requirement of the role
- **6.** Demonstrated experience maintaining and strengthening stakeholder relationships and a demonstrated capacity to work in a collegiate manner
- 7. Demonstrated publication record in high-quality refereed journals, conferences, equivalent textbooks or teaching resources
- 8. Demonstrated ability in undertaking outstanding research and leading a research team and project. A proven record of obtaining competitive grants for research will be highly regarded
- 9. Demonstrated record of successfully supervising postgraduate research students
- **10.** Ability to work positively and cooperatively with students and a demonstrated strong record of teaching experience in a tertiary environment including course coordination
- **11.** Demonstrated ability to motivate, actively engage and educate a given audience. Proven ability, commitment and passion for engaging in scholarly and research activities
