Summary of the broad purpose of the role in relation to the organisation's goals

The Cook is responsible for the ordering of non-impress food supplies, plating of meals, menu selections and ensuring that quality control of food production is maintained to an acceptable standard.

Reporting/Working Relationships

The Cook is responsible directly to the <Services supervisor> on a day-to-day basis and ultimately responsible to the <Facility manager>.

Special Conditions

- Prescribed Positions under the Child Safety (Prohibited Persons) Act 2016 must obtain a satisfactory Working With Children Check (WWCC) through the Department of Human Services (DHS) Screening Unit.
- Approved Aged Care Provider Positions as defined under the Accountability Principles 1998 made in pursuant to the Aged Care Act 2007 (Cth) must obtain a satisfactory National Police Certificate (NPC) through the South Australian Police confirming the clearance is for the purpose of unsupervised contact with vulnerable groups.
- > Prescribed positions under the Disability Services Act 1993 must obtain a satisfactory Disability Services Employment Screening through the Department of Human Services (DHS) Screening Unit
- NPCs and DHS Disability Services Employment Screenings must be renewed every 3 years thereafter from date of issue.
- > WWCCs must be renewed every 5 years thereafter from date of issue.
- > The position is primarily located at Wallaroo Hospital but the incumbent maybe required to work from other sites within Yorke and Northern LHN area.
- > Must be an Australian Resident or hold a current working visa.
- > Current driver's license and willingness to drive.
- Appointment is subject to immunisation risk category requirements (see page 1). There may be ongoing immunisation requirements that must be met.
