### Overview of program

Anglicare Victoria's Home Based Care program is funded by the Department of Health and Human Services (DHHS) to provide monitoring and support to home based care placements arranged for the most vulnerable children as a result of child protection involvement. The program ensures the ongoing safety, stability and developmental needs of children and young people are met.

The Team Leader Home Based Care is a leadership role in the team, with responsibility for oversight of the Home Based Care program within the region, in particular, early intervention, Circle program and Intake. As such this role requires a strong focus on managing systems to support reunification, kinship or other stable care options. This team particularly focuses on early intervention, Circle program and Intake.

This position manages a complex program area with responsibility for the management of a budget and significant risks. The role has the opportunity to influence an environment building on the strengths of carers and young people to create positive, enduring outcomes.

The specified programs to be managed may change over time to reflect organisational needs.

### **Position Objectives**

1.	To coordinate the delivery of a high quality program that provides genuine and positive outcomes for clients.
2.	To work in conjunction with the Program Manager to plan and implement responses in relation to sector and service developments.
3.	To ensure appropriate processes are in place to enable continuous improvement of services and to promote best practice and ongoing quality improvement of the program.
4.	To ensure the program is operated in accordance with service and quality standards, program targets, DHHS service agreements, organisational policies and accepted standards of practice.
5.	To provide ongoing support, supervision, performance management, learning and development of team members in this program.





# Key responsibilities

The key responsibilities are as follows but are not limited to:

1.	Ensure the delivery of program services meets client requirements and is in accordance with the service agreements and within program budget requirements.
2.	Monitor performance targets, outcomes, quality standards in service agreements, legislative and policy requirements, quality of care issues, reportable conduct and complaints.
3.	Monitor program performance and outcomes through the collection and analysis of service data and implement changes to the operation of the program when required.
4.	Participate in the development and maintenance of quality partnerships with key agencies including the Victorian Government Department of Health and Human Services (DHHS) and other community services providers.
5.	Participate in the professional development and recruitment of staff, including supporting a culture of reflective practice, quality supervision and coaching.
6.	Initiate service improvements and participate in service redevelopment and redesign.
7.	Contribute to the preparation of the program budget and work with the Program Manager to maintain accountability for the program budget and implement corrective action as required.
8.	Provide staff supervision, and manage staff performance, and develop team cohesion and effectiveness.
9.	Ensure compliance with team administrative requirements, including those in Preceda, Converga, PageUp, and Riskman.





# **Key Selection Criteria**

The Key Selection Criteria are based on role specific requirements **and** the Anglicare Victoria Capability Framework. Applicants are required to provide a written response to **both** a) and b).

### a) Role specific requirements

Applicants are required to provide a written response to the role specific requirements. The five criteria are to be addressed individually (no more than 2 pages in total).

	3. Demonstrated knowledge of, and experience in the application of relevant theoretical approaches that underpin casework practice (including theories of child attachment, development and abuse) to vulnerable children, young people and families.
	<ol> <li>Well-developed skills and experience in delivering programs and services within required timeframes and budget parameters.</li> </ol>
	<ol> <li>Demonstrated ability to work in partnership with key stakeholders.</li> </ol>
	<ol> <li>Demonstrated experience in developing and leading a positive and engaged team environment.</li> </ol>





## **Key Selection Criteria (continued)**

### b) Anglicare Victoria Capability Framework

Applicants are required to provide a written response to the Anglicare Victoria Capability Framework. Applicants are to describe how they demonstrate the characteristics in each of the three nominated capability groups; **Personal Qualities**, **Relationship and Outcomes**, and **Leading People** (no more than 1 page in total).

The Anglicare Victoria Capability Framework describes the capabilities required to meet the expectations of clients, colleagues and communities in today's changing environment.

These capabilities work together to provide an understanding of the knowledge, skills and abilities required of all employees.
