The School of Mathematics (www.monash.edu/science/schools/school-of-mathematics) is one of the largest of the five Schools in the Faculty, and has close working collaborations with other Schools/Departments such as Physics and Astronomy, Earth, Atmosphere and Environment, Computer Science; and other faculties such as Business and Economics, Arts, Medicine, IT and Engineering. The School has strong links with outside institutions such as CSIRO, the Defence Science and Technology Organisation, and the National Australia Bank and a large number of research institutes and universities around the world. In the 2018 ERA assessment, Monash University received a top rating of 5 (well above world standard) for applied mathematics. With the continued expansion and strengthening of Monash Mathematics, the international standing of Mathematics at Monash will continue on its upward trajectory.

The School is multidisciplinary with very active groups in algebra and discrete mathematics, analysis and geometry, topology, applied mathematics, financial mathematics, fluid dynamics, statistics and stochastic processes, numerical analysis and scientific computing, PDEs, operations research, optimisation, machine learning, and mathematical biology. The School provides undergraduate teaching for students in the Faculties of Science, Engineering and Information Technology; as well as postgraduate training in its key areas of research.

The School has approximately 60 Academic and Research staff, 150 Teaching Associates, 6 Professional staff, 60 PhD and 60 Masters Students.

## POSITION PURPOSE

A Level B research-only academic is expected to carry out independent and/or team research within the field in which they are appointed and to carry out activities to develop their research expertise relevant to the particular field of research.

This position's primary purpose is to conduct theoretical analysis and perform efficient implementation for novel discretisation techniques applied to the numerical solution of partial differential equations. In particular, the intended project is related to the simulation of the coupling between diffusion of intracellular calcium and elasticity in different types of cells (embryonic epithelial, cardiomyocytes, and other single cells or cell compounds), using virtual element methods on polytopal meshes.

## KEY RESPONSIBILITIES

Specific duties required of a Level B research-only academic may include:

1. The conduct of research either as a member of a team or independently and the production of conference and seminar papers and publications from that research
2. Supervision of research-support staff involved in the staff member's research
3. Guidance in the research effort of junior members of research-only Academic staff in their research area
4. Contribution to the preparation or, where appropriate, individual preparation of research proposal submissions to external funding bodies
5. Involvement in professional activities including, subject to availability of funds, attendance at conferences and seminars in the field of expertise
6. Administrative functions primarily connected with their area of research
7. Occasional contributions to the teaching program as determined by the requirements of the School
8. Co-supervision or, where appropriate, supervision of major honours or postgraduate research projects within the field of the staff member's area of research
9. Attendance at meetings associated with research or the work of the organisational unit to which the research is connected and/or at departmental, school and/or faculty meetings and/or membership of a limited number of committees
10. Other duties as directed from time to time

## KEY SELECTION CRITERIA

## Education/Qualifications

1. The appointee will have:

- A doctoral qualification in Applied Mathematics, Numerical Analysis, Scientific Computing, or a related field.


## Knowledge and Skills

2. Sufficient drive and ability to perform novel research of international standing
3. Sound knowledge and experience in the analysis and implementation of virtual element schemes or similar polytopal methods
4. Demonstrated capacity for the preparation of scientific manuscripts and/or research proposals, commensurate with the career of the applicant
5. Advanced background on solid mechanics and/or mathematical biology is welcome but not a requirement
6. Experience in supervising and working with major honours or postgraduate students within the discipline
7. The ability to work both independently in a research environment and within an inter-disciplinary team
8. High level organisational skills, with demonstrated capacity to establish and achieve goals
9. Excellent written and oral communication skills
10. Advanced computer skills with experience using programming languages such as pyhon, Julia, and C++
11. Willingness to work in a collegiate manner with other staff in the workplace
