- Keep current with production methods, software and reporting tools. Produce programs, platforms or bulletins as required.
- Work collaboratively with the team, sharing experience and knowledge as well as training. Take direction and offer guidance and leadership. Manage your time and that of colleagues in production situations when required.

- Identify and manage editorial risks. Proactively follow newsroom and corporate policy. Deal quickly with complaints and audience contacts.
- Generate stories that are relevant to a broad section of Australians and reflect the cultural, geographic and socio-economic diversity of the country.
- Actively engage with communities in Australia's outer suburbs to find and tell stories that are relevant for them and in line with the News strategy.
- Actively promote the ABC values and apply all relevant workplace policies and guidelines.
- Cooperate with any reasonable instruction, procedure or policy relating to safety and take reasonable care for your own safety and that of other people who may be affected by your conduct while at work. Additional WHS responsibilities apply to Managers and Supervisors, Team Directors, and other Officers.
