The Natural Capital Investment Initiative seeks to align and harmonise the way natural capital is measured. It aims to create the enabling environment for more consistent natural capital measurement at scale. It is seeking to do this by 1) developing an agreed on, comprehensive set of natural capital measures at the property level, and 2) exploring public and private incentives for farmers to actively measure and manage their natural capital. The Program team is working with incentive providers (e.g. government, financial institutions, and food retailers) to explore how the costs of natural capital measurement can be shared along the value chain allowing farmers to financially benefit from measuring and improving natural capital on their properties.

POSITION PURPOSE

The **Project Manager (NCII)** plays a key role in delivering core projects/activities within the Natural Capital Investment Initiative team which seeks to better integrate and make visible the value of nature in corporate and government decision-making.

The Project Manager utilises their skills in project management, stakeholder engagement and research and analysis to provide a range of high-level project coordination and delivery services to contribute to the successful delivery of this program of work. This includes undertaking project management activities as well as contributing to research, analysis and knowledge translation for decision-maker audiences, and participating in stakeholder engagement activities (across government, food supply chain companies, industry bodies, financial institutions, research organisations and agriculture technology providers). In addition, the Project Manager provides evidence on specific policy interventions, prepars reports and provides hands-on advice to decision makers.

This position works closely with the Program Impact Manager to support strategic direction and agreed project plans. Moreover, the Project Manager works s as part of a project team and will work effectively with colleagues to ensure effective coordination and delivery across multiple streams of work.

KEY RESPONSIBILITIES

- 1. Undertake a range of project management duties with a focus on excellent project delivery, including: working with stakeholders to scope, plan and deliver project tasks and outputs, delivering effective project management communications, monitoring and reporting against impact metrics, budget, timeframes and other performance indicators, managing a schedule of project meetings, anticipating and managing risks
- 2. Undertake research and analysis activities (desktop reviews of literature and policy, stakeholder interviews, data collection and analysis) and develop key knowledge assets and outputs (policy briefs, position papers, reports, presentations, articles, etc.) to communicate research and inform action from policy-makers, financial institutions and corporates, with a view

to embed the value of nature in decision-making. This includes collaborating with key stakeholders to prepare position papers, briefings, reports and presentations for a range of audiences

- **3.** Provide guidance to project team members, where required, including liaising with external consultants and contractors, with a focus on excellence in project delivery
- **4.** Develop and maintain excellent relationships with key stakeholders and decision-makers across Australian and international agriculture, conservation, food and finance sectors with a view to act as a trusted adviser to key decision-makers and contribute to collaborative efforts to affect policy change
- **5.** Develop expertise in key knowledge areas related to the agriculture, food, finance and conservation sectors including policy, regulatory, technology, and socio-economic aspects. In line with this, proactively manage relationships with key experts within the research community and industry and ensure latest knowledge is shared across the organisation
- 6. Contribute to the overall delivery of the Food, land and Ocean system, working collaboratively with colleagues within the team and the organisation towards the delivery of the organisation's goal. Provide strategic advice to the senior leadership team on strategic trends, opportunities and risks and provide input into organisational strategic planning and team strategic planning
- 7. Other duties as directed from time to time

KEY SELECTION CRITERIA

Education/Qualifications

- 1. The appointee will have:
 - A degree qualification in a relevant field related to natural capital, including conservation, agriculture, sustainable finance, or food supply chain; or
 - extensive experience and management expertise in technical or administrative fields; or
 - an equivalent combination of relevant experience and/or education/training.

Knowledge and Skills

- 2. Highly developed project management skills and project management experience with a track record of successfully coordinating projects, establishing priorities, coordinating stakeholder inputs and producing deliverables in accordance with agreed standards, timeframes and budgets
- 3. Advanced computer literacy with experience in the use of project management tools.
- **4.** Demonstrated research, analytical and problem-solving skills and the ability to identify and recommend solutions to challenging issues
- 5. Highly-developed interpersonal and communication skills with the ability to translate complex or technical information into compelling professional documentation for various audiences with a view to affect change. Including the ability to prepare and provide expert advice in areas of specialist or research knowledge
- **6.** Ability to build effective working relationships with a network of internal and external stakeholders to maintain effective collaboration and influential relationships.
- 7. Demonstrated ability to work as an effective member of a team as well as the ability to exercise high levels of independence, judgement and initiative
