Overview of program

Child and Family Services in the St Luke's Region consist of a range of programs that provides support to families who have dependent children 0-18 years.

The aim of Child and Family Services is to provide in-home and community interventions with ranging intensities depending on the family needs, in a child-centred, family focused way.

Position Objectives

1.	Work within the Best Interest Framework and abide by relevant policy practice guidelines.
2.	Provide outreach support/case-work response to families in a child-centred, family focused way, where the safety and wellbeing of children and young people are paramount
3.	Work within a collaborative care team approach with relevant stakeholders, including Child Protection and Aboriginal organizations, to promote best outcomes for client.





Key responsibilities

The key responsibilities are as follows but are not limited to:

1.	Provide intensive outreach to families across six local government areas; with a focus on placement prevention and the safety and wellbeing of children and adolescents within their family home
2.	Actively engage children, youth and families to the program via home visits, telephone contact, care team meetings and professionals meetings.
3.	Support an integrated service system for all families by working across child and family programs to support times of high demand.
4.	Fulfil the program requirements regarding case load requirements, case records, statistics and other data collection.
5.	Make an active commitment to the development and maintenance of a cohesive, multi-disciplinary team and participate in staff meetings, team meetings and staff development.
6.	Work with the family within flexible hours; that is negotiated with the family and the agency.
7.	Other duties as negotiated by the team leader or program manager.





Key Selection Criteria

The Key Selection Criteria are based on role specific requirements **and** the Anglicare Victoria Capability Framework. Applicants are required to provide a written response to **both** a) and b).

a) Role specific requirements

Applicants are required to provide a written response to the role specific requirements. The five criteria are to be addressed individually (no more than 2 pages in total).



- A relevant tertiary qualification in Social Work, Psychology, Early Childhood Specialist and/or related behavioural sciences at a degree level or associated diploma level with substantial experience in the relevant service stream.
- 2. Resilience to work with and support clients who have been exposed to trauma.
- 3. Demonstrated ability to conduct comprehensive safety and wellbeing assessments and work within the Best Interest Principles 'as outlined within the Children, Youth and Families Act 2005.
- 4. Sound understanding of the Child Protection and welfare system, and experience in collaboration with a range of professionals in a care team approach.
- 5. Excellent written and verbal communication, time management and organisational skills.



Key Selection Criteria (continued)

b) Anglicare Victoria Capability Framework

Applicants are required to provide a written response to the Anglicare Victoria Capability Framework. Applicants are to describe how they demonstrate the characteristics in each of the two capability groups; **Personal Qualities and Relationship and Outcomes** (no more than 1 page in total).

The Anglicare Victoria Capability Framework describes the capabilities required to meet the expectations of clients, colleagues and communities in today's changing environment.

These capabilities work together to provide an understanding of the knowledge, skills and abilities required of all employees.
