POSITION PURPOSE:

A Level E academic is expected to exercise a special responsibility in providing leadership and in fostering excellence and impact in research, teaching, professional activities, and policy development in the academic discipline within the department or other comparable organisational unit, within the University and within the community, both scholarly and general. This includes team building, mentoring and forging collaborative research and teaching partnerships that develop and strengthen the discipline within Monash University. The appointment will bring innovative teaching methods to classrooms and increase the disciplinary and school-based research capacity. In line with Monash University's Strategic Plan, Impact 2030, the appointee would be expected to work across the Arts Faculty and wider University in developing research projects with a strong emphasis on the societal and governance challenges posed by climate and environmental change. Collaboration with relevant industry, government and community organisations is also expected to support teaching and research innovation.

KEY RESPONSIBILITIES

Specific duties required of a Level E academic may include:

1. Research

- Actively engage in original and collaborative research that lead to high-quality refereed journal publications or outputs with high level academic or commercial publishers
- Foster research excellence through procuring competitive research grants, leading significant projects and working with other staff to develop research projects
- Supervision of PhD students and postgraduate students engaged in coursework and research projects
- Significant contribution to the profession and/or discipline both nationally and internationally

2. Teaching and Education activities

- Acting as subject coordinator and Chief Examiner, which includes a range of administrative functions, the majority of which relate to the subjects the academic teaches
- Preparation and delivery of innovative and engaging subject materials using online platforms and face-toface activities
- Provide innovative and effective leadership for the expansion of the Faculty's HDR program by attracting high quality HDR students
- Discipline and/or program coordination including offering guidance to assistant lecturers and supervision of sessional staff in teaching programs/s if required

3. Service

- Contribute to academic and administrative leadership within the Faculty by participating in the development of policy and strategy
- Maintain and broaden collaborative partnerships with relevant faculties and departments/schools within the University and community
- Maintain and broaden collaborative partnerships with external agencies both nationally and internationally, making a significant contribution to the profession
- 4. Other duties as directed from time to time

KEY SELECTION CRITERIA

Education/Qualifications

- **1.** The appointee will have:
 - A doctoral qualification, or equivalent accreditation and standing, and recognition as a leading authority in societal and governance dimensions of environmental change within the field of Human Geography.

Knowledge and Skills

- **2.** Evidence of outstanding scholarly activity of an international standing focused around societal and governance dimensions of environmental change within the discipline of Human Geography
- **3.** Demonstrated ability to develop and lead a coherent program of research and an excellent track record of obtaining external, competitive, and innovative research funding
- **4.** Record of successful supervision of postgraduate research students and the ability to make a significant contribution to postgraduate training programs in Human Geography
- 5. Proven excellence in teaching in Human Geography at both undergraduate and postgraduate levels
- **6.** High level of interpersonal skills and a proven ability to establish collegial working relationships with colleagues, students and members of community and professional bodies
- 7. Proven professional leadership qualities and capacity for executive administrative responsibilities
- 8. Evidence of sustained relationships with industry, government agencies and professional bodies coupled with vision for the future needs and development of Human Geography within Australia and internationally

OTHER JOB RELATED INFORMATION

- Travel to other campuses of the University may be required
