Overview of program

The Anglicare Family Services Program is funded by the Department of Health and Human Services (DHHS) to deliver a range of interventions to vulnerable children, youth and families. Many of these families have long histories of involvement with child protection and community agencies, and require flexible and innovative interventions to address their needs to support their safety and wellbeing.

The Family Services program covers the outer-east catchment (Yarra Ranges, Maroondah and Knox local government areas) and consists of a range of programs including Child FIRST, Family Services, Rapid Response, Intensive Family Services and Cradle to Kinder.

The Intensive Family Services program specifically focusses on delivering a placement prevention and reunification service for Child Protection clients on a Family Preservation or Family Reunification Order. The program aims to prevent an Out of Home care (OoHC) placement for children by providing families with intensive interventions, developing plans to reduce risks to children and increase the capacity of parents to provide for their safety and wellbeing. For children residing in OoHC, this program supports reunification by assisting families to create and maintain safe and nurturing home environments.

Position Objectives

1.	Actively engage children, youth and families referred to the program
2.	Provide intensive in-home interventions that improves the capacity of the families to achieve their goals, particularly the safety and wellbeing of children and young people.
3.	Undertake regular risk and needs assessments, using relevant and contemporary theory and frameworks
4.	Partner with the family and work effectively with Child Protection and the care team to develop and review action plans aimed at placement prevention or reunification.
5.	Support the family's connection with formal and informal supports and services in the community and develop collaborative working relationships with these supports
6.	Meet program, policy and legislative requirements in the program, such as partnership with Child Protection

Key responsibilities

The key responsibilities are as follows but are not limited to:

1.	Actively engage (including outreach visits) children, young people and families, including those who may be resistant, by being flexible, responsive, strengths-focused and creative
2.	Conduct comprehensive risk and needs assessments using relevant and contemporary frameworks, theory and practice models that identify both the capacity and constraints of the family to make necessary changes.
3.	Provide intensive in-home interventions to families that achieves the goal of placement prevention or reunification.
4.	Link families to the community supports they require and promote a collaborative care team around the family.
5.	Work effectively with Child Protection and other services to achieve the intended goals of the family and a coordinated service response.
6.	Actively contribute to a positive and learning culture and participate in reflective practice.
7.	Fulfil program requirements regarding case recording, data collection, registration standards and other requirements

Key Selection Criteria

The Key Selection Criteria are based on role specific requirements **and** the Anglicare Victoria Capability Framework. Applicants are required to provide a written response to **both** a) and b).

a) Role specific requirements

Applicants are required to provide a written response to the role specific requirements. The five criteria are to be addressed individually (no more than 2 pages in total).

 <p>Role Specific</p>	<p>1. A relevant tertiary qualification in Social Work, Psychology and/or related behavioural science at a degree level; or associate diploma level with substantial experience in the relevant service stream, or less formal qualifications with specialised skills sufficient to perform at the required level.</p>
	<p>2. An excellent understanding of the social context of child abuse and neglect, the impacts of trauma and experience in applying relevant theoretical approaches to deliver outcomes, particularly for children on Child Protection orders.</p>
	<p>3. Experience in active engagement of vulnerable children, youth and families and delivering a range of interventions to improve their outcomes. Particular experience is required for families at risk of child removal and supporting family reunification.</p>
	<p>4. Excellent experience in conducting risk and needs assessments, and developing and implementing action plans to achieve desired outcomes</p>
	<p>5. Skills in case management, working effectively with Child Protection and supporting collaborative care teams</p>

Key Selection Criteria (continued)

b) Anglicare Victoria Capability Framework

Applicants are required to provide a written response to the Anglicare Victoria Capability Framework. Applicants are to describe how they demonstrate the characteristics in each of the two capability groups; **Personal Qualities and Relationship and Outcomes** (no more than 1 page in total).
