Qualifications	Possess a relevant trade qualification, Diploma or higher at a recognised institution or equivalent extensive experience working within the entertainment industry.	
	Basic or Intermediate Riggers licence, Fire Emergency Warden training, Test & Tag, Elevated Work Platform licence, Occupational Health and Safety and `in house' equipment relevant to the position are preferred.	
Experience	<ul> <li>Knowledge and understanding of the theory involved in lighting concepts, and how to utilise this knowledge to achieve and create specific lighting and artistic effects, as well the contribution to the overall professional effect of the production. Experience is required to be able to apply this knowledge for different situations and venues including outside events and broadcasts</li> <li>Knowledge of the lighting console programming and operation is desirable</li> <li>A general electrical knowledge of wattage, amps, circuit breakers, earthing and three phase wiring. Also the principles of industry equipment communication protocols and data distribution networks including Ethernet and DMX-512 are essential to be able to patch and connect equipment safely, to select the appropriate wattage for size/intensity requirements, and to know how much power is being loaded on each circuit</li> <li>A knowledge and understanding of the technical lighting equipment used in the industry is essential</li> <li>Appropriate communication skills to liaise with presenter staff. Well-developed interpersonal skills are required to resolve issues. This may include a need to convey technical information to people with a non-technical background</li> <li>Be able to accurately set up and operate equipment, in regards to specific skills and experience, confidently and without delay</li> <li>Strong service ethic and understanding of production and presenter needs</li> <li>Demonstrating a clear understanding of "performance" etiquette, including a comprehensive knowledge of theatre traditions, protocol and terminology.</li> <li>The ability to work under pressure, to prioritise work and resolve problems quickly and efficiently to ensure daily deadlines are achieved</li> <li>An understanding of other technical departments work practices in Production, to ensure smooth delivery of events and services</li> <li>Knowledge of all ACM venues and technical facilities and capabilities is desirable</li> </ul>	
Other (i.e. legal or physical)	<ul> <li>General office work from time to time, with a strong emphasis on manual work while maintaining safe OH&amp;S practices is required including outdoor and remote locations when required</li> <li>May be required to work at height</li> <li>Must be able to lift and carry technical equipment.</li> <li>Ability to make quick decisions under pressure.</li> <li>Due to the nature of work within the theatre environment this can involve long hours, irregular work patterns &amp; heavy physical work</li> </ul>
