This role sits within the Infrastructure Services Division, which enables the University to conduct core business and supports its strategic direction. The two functions of this role are crucial in ensuring the safety and wellbeing of our students, staff and the wider community.

- Provide training and education to the University community around emergency procedures and security.
- Manage projects that will include, but are not limited to, high level report writing, sector operational reviews, website reviews, website content management and the development of educational materials.
- Ensure there is a culture of outstanding customer service and accountability with appropriate controls in place for both Security and Emergency Management.
