POSITION PURPOSE

The **Senior Analyst** is responsible for developing impactful content through translating research, analysis and insights for ClimateWorks' initiatives within the Industry System team. They will generate reports and presentations based on their findings from identifying and reviewing reports and interviewing experts to gather data relevant to the projects.

The role will have an initial focus on the Australian Industry Energy Transitions Initiative (ETI) which aims to accelerate action towards achieving net zero emissions in Australia's key heavy industry supply chains. As part of the Australian Industry ETI's Engagement Team, the role will contribute to achieving the following objectives:

- To help achieve the desired systems change by producing and distributing impactful, strategic program communications and other informal outputs targeted at specific stakeholder groups as well as to shift the public narrative
- To strengthen an industry voice on net-zero supply chains by working with Australian Industry ETI
 participants to shape and promote a shared industry narrative on the feasibility and opportunities of
 a transition to net zero emissions supply chains

The Senior Analyst will work in close collaboration with ETI project stakeholders, both internal and external (business and government partners), to create and deliver outputs in accordance with agreed timeframes, design briefs and budgets. The Analyst will also work collaboratively with ClimateWorks' Centres of Excellence, particularly the Communications team to achieve targeted outcomes.

KEY RESPONSIBILITIES

- Collaborate with internal and external stakeholders to translate project insights into high quality content
 designed to make an impact on target audiences, including business, government, media and the general
 public, through a variety of formats, including technical reports, data visualisations, concise position papers,
 ministerial briefings, and presentation slides for conferences
- **2.** Develop and maintain a network of relevant stakeholders within the industry system and foster internal collaboration to ensure the successful delivery of outcomes
- **3.** Develop work plans in line with the communications and engagement plan and manage the timely delivery of outcomes by undertaking regular monitoring of project schedules and risks
- **4.** Support ClimateWorks to develop organisational knowledge and capability by actively supporting knowledge sharing initiatives and ensuring key project messages are delivered internally
- **5.** Support decision making processes by actively participating in strategic discussions and impact monitoring, evaluation and learning in line with ClimateWorks strategy
- 6. Other duties as directed from time to time

KEY SELECTION CRITERIA

Education/Qualifications

- **1.** The appointee will have:
 - A degree qualification in a relevant field with extensive relevant experience; or
 - extensive experience and management expertise in technical or administrative fields; or
 - an equivalent combination of relevant experience and/or education/training.

Knowledge and Skills

- 2. Proven experience in writing to influence a variety of audiences across business and government (e.g. journalism, public relations, marketing), including experience translating complex or technical information into engaging, easily understood content with an informative use of quantitative and qualitative data, visualisation skills, and excellent quality assurance skills
- **3.** High level of analytical, conceptual, research and investigative skills including an ability to quickly assimilate new concepts and information and translate this work to develop impactful, targeted content to meet project requirements within a structured approach
- 4. Knowledge of the Australian heavy industry, resources and energy sectors; the relevant federal / state government policy landscapes including an understanding of the international context; and an understanding of the key climate change technologies and concepts most relevant to hard to abate industrial processes (such as electrification, circular economy, hydrogen technology, Carbon Capture Usage and Storage)
- 5. Highly developed planning and organisational skills, with experience establishing priorities and setting and meeting deadlines. A background of working on large, complex, multi-stakeholder programs would be advantageous
- **6.** Highly developed relationship management skills, including the ability to interact, influence and negotiate at senior levels with a variety of stakeholders at all levels in the investment, corporate and government and non-government sectors. An existing professional network and profile in these sectors would be advantageous
