Overview of Program

Anglicare Victoria offers a comprehensive network of services to young people, children and their families / caregivers living across Victoria. We seek to ensure the provision of high quality services that will bring about significant improvements in the life experience of the young people, children and families / caregivers with whom we work. Anglicare Victoria requires that staff commit to continuing to develop their cultural competence. Anglicare Victoria is committed to equal opportunity and improved outcomes for Aboriginal peoples. Anglicare Victoria is committed to developing an official Reconciliation Action Plan that bears the Reconciliation Action Trademark.

The North-Central region of Anglicare Victoria is spread across north, central and western Victoria with offices as far east as Wangaratta, to the west in Mildura, and to Kyneton in the south. The main office in the region is in Bendigo. The position may be based in Kyneton, Bendigo, Swan Hill or Mildura, depending on the applicant.

The region provides a wide range of services to children, young people, families and other individuals in the community. The services include general family support, early years development, intensive placement prevention, foster care, kinship care, adoption and permanent care, residential care, Gambler's Help, Victim's Assistance, financial counselling, community development, homelessness support, youth justice, and youth services. There are approximately 300 staff and 200 volunteers working in the region.

Position Purpose

The Regional Development Manager is a key leadership role in the Region with a focus on sector reform, business development, service integration, strategic relationship management and partnerships. The incumbent will be a member of the Regional Management Team alongside the other managers in the region.

The North-Central region covers multiple DHHS areas and there is a need to maintain a high level of connection to key stakeholders and decision making groups across the region. The Regional Development Manager will be required to represent Anglicare Victoria in a range of forums and networks across the region.

The Regional Development Manager is required to work collaboratively with other business and development roles across Anglicare Victoria in relation to planning, innovation and service integration across the DHHS North Division. This role will also work closely with the Anglicare Victoria General Manager Business Development and North-Central Program Managers.

Regional Development Managers are members of the Anglicare Victoria Senior Management Group.

Position Objectives

Working in partnership with the Divisional Director, Regional Director, General Manager Business Development & Evidence Informed Models, the key position objectives of the Development Manager role are as follows:

1.	Undertake a lead role with sector reform. This includes the development of Anglicare service and program integration, as well as pursuing opportunities for business development.
2.	Play an active role as part of the Regional Leadership team.
3.	Take a lead with practice development across the region and undertake program and case reviews, as well as critical incident analysis.
4.	Take a lead role with external stakeholder partnerships and related processes.
5.	Ensure collaboration across regions by establishing relationships with other Anglicare Victoria Development Managers.
6.	Contribute to the overall planning, development, operations and evaluation of Anglicare Victoria services in the Region.

Key Responsibilities

Working in partnership with the Divisional Director, Regional Director, General Manager Business Development & Evidence Informed Models, the key responsibilities are as follows:


1.	Practice & Business Development <ul style="list-style-type: none"> • Develop and maintain communication links and cooperative arrangements with the appropriate funding body, community service providers and other key stakeholders relevant to the program. • Pursue opportunities for service development and advancement of organizational strategic projects • Promote the development of a positive organisational and workplace culture in line with the principles of the organisation and the expectations of Anglicare's Strategic Plan. • Contribute to the development of an integrated service system capable of customising creative service responses to client needs and service contract expectations. • Identify and progress opportunities to expand operations through the development of strategic partnerships and other consortium arrangements. • Identify, evaluate and ensure continuous practice improvement and development across the region, as well as undertake program and case reviews. • Undertake a key lead role in negotiations with DHHS and other funding bodies as required. • Lead the development of submissions / tenders • Lead the operational implementation of new models of service delivery.
2.	Networking & Relationship Management <ul style="list-style-type: none"> • Continue or enhance relationship management with key Government and other stakeholders. • Develop and maintain good working relationships with Development Managers, Quality Managers and Program Managers.
3.	Performance & Outcomes Responsibility for Performance Reporting, outcomes, evaluation, and relevant data reporting & critical incident analysis across the region
4.	Strategic Planning Contribute to the development of regional business plans that will bring about the achievement of <i>Strategic Directions</i> and quality service outputs and outcomes through the astute deployment of all available resources and infrastructure.

Key Selection Criteria

The Key Selection Criteria are based on role specific requirements **and** the Anglicare Victoria Capability Framework. Applicants are required to provide a written response to **both** a) and b).

a) Role specific requirements

Applicants are required to provide a written response to the role specific requirements. Each of the role specific criteria are to be addressed individually (no more than 2 pages in total).

 Role Specific	1. Tertiary qualifications, preferably in social sciences and/or management.
	2. Demonstrated experience planning, development and management of human services.
	3. Comprehensive understanding of the human service delivery system, with particular reference to services for families and children in out of home care.
	4. Demonstrated ability to mediate and negotiate appropriate outcomes in complex work situations.
	5. Outstanding communication skills, with demonstrated experience in tender writing and submission development.
	6. Demonstrated ability to provide leadership and consultation in relation to practice in the area of Placement and Support and Family and Community Services.

Key Selection Criteria (continued)

b) Anglicare Victoria Capability Framework

Applicants are required to provide a written response to the Anglicare Victoria Capability Framework. Applicants are to describe how they demonstrate the characteristics in each of the three nominated capability groups; **Personal Qualities**, **Relationship and Outcomes**, and **Leading People** (no more than 1 page in total).

The Anglicare Victoria Capability Framework describes the capabilities required to meet the expectations of clients, colleagues and communities in today's changing environment.
