## **Position Purpose**

This position will provide specialist technical advice and undertake moderately complex building compliance assessments for Council Buildings in accordance with the Queensland legislation to meet the needs of the community within the Moreton Bay Regional Council area.

### **Key Responsibilities and Outcomes**

#### Operational

As Senior Building Compliance Officer within the Buildings and Facilities Planning team you will:

- Be responsible for identification and assessment of Council obligation for the most current Building Regulation
- Develop a building compliance governance framework and procedural documentation to ensure compliance and support compliance activities
- Establish roles and responsibilities among different Council directorates and departments to address building compliance in its entirety with the Building Regulation and Act
- Establish a formal monitoring and reporting framework to provide guidance for visibility, timelines of information and flag any issues regarding Building Regulation compliance obligations to ensure ongoing building compliance
- Develop a compliance obligation register, document and risk assessments for all appropriate obligations under the Building Regulation and Act
- Initiate and prepare formal building compliance reports
- Undertake moderately complex building compliance assessment to ensure technical compliance with the building code and legislation
- Assess and issue building compliance report in accordance with the relevant legislative, policy and business requirements for Council's building projects
- Provide specialist technical advice to key stakeholders on building certification matters.
- Support the assessment of emergency and high-risk building and development compliance matters (including matters relating to public safety, injury to persons or damage to property).
- Conduct investigations of compliance matters or concerns
- Build strong relationship with key internal and external stakeholders to ensure quality service outcomes are achieved.
