### **Overview of program**

Child and Family Services in the St Luke's Region consist of a range of programs that provide support to families who have dependent children 0-18 years with the aim of providing quality in-home and community interventions that vary in intensity.

The Families First program works with families who are involved with Child Protection services. The program provides short term intervention and support to families across 6 Local Government Area's within the Loddon catchment.

The support is delivered over a 6-8 weeks period. The collaboration with families is targeted, intensive, goal focused and delivered in a child-centred, family focused way and occurs within family's homes or the community setting. The family worker will partner with families and key stakeholders; supporting the family to make the changes that may be needed for children to be safe in the care of their parents or caregiver.

The program aims to ensure that it is providing an immediate response to prevent children from being placed outside of their home, or working quickly to return children back into their families care.





## **Position Objectives**

1.	To represent the agency with integrity and promote and uphold the agencies values.
2.	To prevent and/or reduce the rate of children entering the child protection system and/or out of home care.
3.	Work collaboratively with Aboriginal Controlled Organisations and Aboriginal families to promote culture as a safety for children.





## Key responsibilities

The key responsibilities are as follows but are not limited to:

1.	To provide intake, assessment and case management response and support to children, young people and their families that focus on safety, stability and wellbeing.
2.	Undertake regular risk and needs assessments utilising the Best Interest Framework and other contemporary frameworks and theories.
3.	Actively engage children, young people and families, including those who may be resistant, by providing flexible and responsive service delivery. This will involve – assertive outreach visits, flexible service delivery hours and using a client centred, strengths-focused practice approach.
4.	Provide quality interventions and services that focus on outcomes to families experiencing vulnerability and the safety and wellbeing of children.
5.	Make an active commitment to the development and maintenance of a learning environment and cohesive multi-disciplinary team, through staff meetings, team meetings, staff development, supervision and reflective practice.
6.	Develop good working relationships with Aboriginal lead agencies to ensure cultural safety in our practice and good outcomes for aboriginal children and young people.
7.	Work within a collaborative care team approach with the school community, other relevant stakeholders, including Child Protection and Aboriginal organisations, to promote best outcomes for client.
8.	Fulfil the program obligation regarding case load requirements, targets, case recording, statistics and other data collection.
9.	Support an integrated service system for all families by working across child and family programs to support times of high demand.

10.	Meet program requirements through the adherence to relevant policy and/or practice guidelines and legislative requirements.
11.	Other duties as requested by the Team Leader or Program Manager.





## **Key Selection Criteria**

## **Key Selection Criteria (continued)**

### b) Anglicare Victoria Capability Framework

Applicants are required to provide a written response to the Anglicare Victoria Capability Framework. Applicants are to describe how they demonstrate the characteristics in each of the two capability groups; **Personal Qualities and Relationship and Outcomes** (no more than 1 page in total).
