THE OPPORTUNITY

In June 2023, the Victorian Premier announced that the Andrews Labor Government had selected Monash University as the preferred education partner for the delivery of the Paramedic Practitioner Program, to establish a new Paramedic Practitioner role within an agreed model of care. It is intended that the program will deliver at least 25 fully trained Paramedic Practitioners by the end of 2026, with the rollout to begin in rural and regional areas. This will be the first time that the Victorian healthcare system will introduce a Paramedic Practitioner role that will support better and accessible care for communities that need it most, reducing unnecessary or potentially avoidable hospitalisations resulting in a more sustainable health system. The Department of Paramedicine is seeking a senior leader to work collaboratively with the Department of Health and Ambulance Victoria in the implementation of this new model of care.

POSITION PURPOSE

The Implementation Lead (Level D) will have a multi-faceted responsibility that spans from the inception of the Paramedic Practitioner Program to its long-term sustainability. They will be instrumental in the activation of the program and will play a crucial role in fostering interprofessional collaborations, which are key to promoting the model of care to stakeholders.

The Implementation Lead will ensure the unification of vision and strategy across all participating organisations, thereby reducing the risk of fragmented implementation. This role requires a unique blend of skills including academic insights, clinical expertise, and administrative capabilities. Beyond that, they will assist in building relationships with key stakeholders and work-integrated learning partners, provide sector intelligence, provide insight into the ongoing development of the Master of Paramedic Practitioner course content, and contribute to an evidence-based approach to the establishment of the model of care. The Implementation Lead will also be responsible for understanding and navigating the legislative landscape, making them indispensable for addressing the national implications of introducing this new model of care.

KEY RESPONSIBILITIES

Specific duties required of a Level D academic may include:

- 1. Provide high-level strategic leadership to the Department and wider Paramedic Practitioner Program by managing, administering and fostering excellence in teaching, research and professional activities
- 2. Work collaboratively with Ambulance Victoria, the Victorian Department of Health and Safer Care Victoria and other relevant stakeholders to ensure successful implementation of the Paramedic Practitioner model of care
- **3.** Engage in scholarly activities, including research, publications, and conference presentations, to contribute to the academic and professional growth of the Paramedic Practitioner program
- 4. Foster research excellence through procuring competitive research grants, contributing to significant research projects and working with other staff to develop research links
- 5. Provide strategic, innovative and effective contribution for the expansion of the Department's Graduate Research program by attracting high quality research students
- 6. Develop and foster national and international relationships with the wider university, local community, consumer advocates, healthcare providers, clinical agencies and emergency services to enhance the program's visibility and promote collaboration for diverse and high-quality clinical placements and student opportunities
- 7. Stay informed about relevant laws, regulations, and policies affecting paramedicine and healthcare education in particular relating to advanced practice roles. Develop and implement program policies in compliance with these regulations
- **8.** Ensure that the Paramedic Practitioner program meets proposed accreditation standards and work towards continuous improvement in alignment with future regulatory and program accreditation requirements
- **9.** Review and report on high-priority issues, risks, and trends to support the program implementation.
- **10.** Attendance at departmental, school and/or faculty meetings and a major role in planning or committee work.
- 11. Other duties as directed from time to time

KEY SELECTION CRITERIA

Education/Qualifications

- 1. The appointee will have:
 - A doctoral qualification in Paramedicine or a related area; and
 - Current registration as a Paramedic with the Australian Health Practitioner Regulation Agency or equivalent;

Knowledge and Skills

- 2. Evidence of a national profile in the area of Community Paramedicine/Paramedic Practitioner programs and an emerging trajectory of being an international leader in the field.
- **3.** Demonstrated understanding of the advanced practice role and implementation of Paramedic Practitioners/Community Paramedicine on a national and/or international level
- 4. Excellent leadership, interpersonal and communication skills and an ability to work independently and as part of a team in a collegiate manner
- 5. Demonstrated experience identifying, maintaining and strengthening stakeholder relationships and a demonstrated capacity to influence strategic outcomes aligned with program objectives.
- 6. Demonstrated publication record in high-quality journals, conferences, equivalent textbooks or teaching resources
- 7. Demonstrated ability in undertaking outstanding research, successfully supervising research students and a proven record of obtaining competitive funding
- 8. Demonstrated ability to motivate, actively engage and educate a given audience
- **9.** Evidence of collaborative and interdisciplinary projects that have a measurable population health outcomes
- **10.** Demonstrated track record of excellence in Paramedicine education and programs of study in a higher education environment

OTHER JOB RELATED INFORMATION

- Travel to other campuses of the University may be required
- Travel to the Department of Health (Vic) or Ambulance Victoria may be required
- There may be a requirement to work additional hours from time to time
