#### **Residential Services**

Anglicare Victoria's Residential Services Program provides accommodation and support for children/young people up to the age of 18 years requiring placement within a Residential Care setting. Within Residential Services we have a number of programs including, Keep Embracing Your Success (KEYS) and Therapeutic Programs.

Our Residential Services Teams support children and young people in a home setting. This provides the young people with 24/7 support, involving everything you might expect when caring for young people. This ranges from creating a stable, nurturing and safe home environment, to supporting young people who, as a result of significant past trauma, may have challenges with expressing emotion and dealing with the challenges of daily life.

The program operates as part of an integrated service response aimed at addressing protective issues, court dispositions covered by the Children and Young Person's Act, issues of family conflict, or family and/or personal and developmental crises.

# Knowledge and skills

- Demonstrated application and understanding of the DFFH standards for Residential care.
- Knowledge of, and experience in the application of relevant theoretical approaches that underpin
  casework practice (including theories of child attachment, development and abuse) to vulnerable
  children, young people and families.
- Demonstrated deep knowledge of trauma and how best to work with young people in Out of Home Care.
- Demonstrated ability to lead a team, set expectations for team and individuals, monitor performance, actively provide feedback and direction and to ensure appropriate development of team members.
- The ability to provide meaningful and effective supervision according to organisational policy and program requirements.
- Excellent time management experience, with the ability to be flexible to the environment in order to effectively manage risks.
- Demonstrated ability to work flexibly to meet the challenging needs of young people.
- Ability to identify, manage and proactively mitigate risks by sound planning, escalation and engagement of key stakeholders.
- Ability to complete case noting to a high standard in line with requirements.
- Significant experience in working with young people living with complex trauma, mental health, disability and substance abuse and with a demonstrated ability to make a positive difference.
- Ability to effectively support young people through crisis using approaches such as Therapeutic
   Crisis Intervention and provide coaching and support to employees in developing their skills through
   appropriate supervision and team reflection and planning.

- Demonstrated understanding Mental Health Act.

### **Your Contribution (responsibilities)**

The key contributions in the role are outlined below:

# Role specific

- Provide leadership, support and supervision to Residential Youth Workers, and play a lead role in the creation of a positive therapeutic culture. Ensuring that new employees are appropriately inducted into the workplace and ongoing feedback to support employees to grow and develop in their role, including regular supervision and appropriate training for all employees.
- Effectively manage team and employee issues as they arise in respect to wellbeing and performance.
- Proactively coordinate employee rosters, including casual and agency staff within the home setting daily expectations/updates.
- Create a positive and supportive environment for the team, ensuring everyone works cooperatively
  with other employees involved in the care and development of the young person in placement to
  ensure that routines, community activities, and behavioural expectations are consistently
  maintained.
- Ensure a culturally safe and respectful environment is provided for young people and employees and that meet the minimum standards with the requirements of relevant legislation and specific legislation for OOHC facilities.
- Ensuring that the physical environment is maintained to a high standard that creates a sense of pride in the surroundings for residents. This includes undertaking appropriate cleaning and general tidiness tasks within and around the home on a regular basis.
- Role model behaviours for young people, to learn from and ensure professional boundaries and confidentiality are maintained at all times.
- Ensuring that procedures relating to the house communication book, records of expenditure, reporting and recording of critical incidents, maintaining client files, and all other operational processes and procedures are followed, and all administration is completed.
- Coordinate and contribute to the intake and assessment of children and young people entering residential care.
- Ensure that appropriate therapeutic interventions and responses are used to work with all children and young people in residential care that promote stability, development and long-term planning.
- Ensure that all Looking After Children (LAC) requirements are adhered to for all children and young people in residential care and are completed in line with DFFH requirements.
- Develop a nurturing, caring and supportive environment, ensuring the young person's vulnerabilities
  are identified and addressed in placement. Including ensuring that care is delivered in respect to
  sensitivity to the needs of young people that identify Aboriginal & Torre Straight Islander and with a
  Culturally and Linguistically Diverse background.

TOMORROWS

- Provide therapeutically informed support and practices that is in best interest of the young person and aligned to the house model i.e., KEYS, Therapeutic, TCI etc.
- Regular review and implementation of individual Plans including Support and Safety plans in collaboration with the young person and other relevant parties to address any identified issues.
- Development and maintenance of effective relationships with other agencies, services, networks and supports that exist in the community and using these to support, inform and create independence for the young people in the program.
- Contribute to the development and maintenance of safe, secure and planned environments where the developmental needs of young people are effectively met as per program guidelines.
- Manage the House Budget on a day-to-day basis and ensure appropriate acquittal processes are undertaken, with any issues flagged with the relevant manager.
- Advocate for the young people in our care in a professional manner with key stakeholders to support positive outcomes.
- In liaison with the Therapeutic Specialist (where applicable) and other care team members ensure that staff are aware of, are trained and that they implement appropriate therapeutic interventions and responses are used to work with all children and young people in residential care that promote stability, development and long-term planning.
- Mange and engage with internal and/or external audits.
- Report any incidents of immediate concerns you have in respect to the Health, Safety and Wellbeing of young people or employees or partners to your Manager or via the appropriate reporting system.

#### General

- Ensure familiarity and compliance with all governance, policies and procedures.
- Adhere to all legislation, program requirements and relevant procedures relating to service provision.
- Undertake mandatory training within the required timelines. Participate in other training and development opportunities to ensure all necessary qualifications, skills, certificates and clearances are obtained to meet the position requirements.
- Maintain appropriate and accurate case notes, records, reports and data-input, in line with the service area and function/position requirements.
- Attend client meetings, team meetings, workshops and conferences, as required.
- Ensure privacy and confidentiality is upheld at all times.
- Professionally represent AV and our services at forums, meetings and training with external agencies.
- Contribute to the development of continuous improvement and initiative strategies.
- Embrace and utilise new ways of working to enhance collaboration, effectiveness and outcomes.
- Individuals may be required to undertake reasonable travel, as part of their position or duties.
