#### 1. Position purpose

This position delivers the Victorian Family Preservation and Reunification (FPR) Response as an evidenced based response working collaboratively with children and families to provide a rapid, intensive and sustained intervention aimed at preventing at risk children entering or re-entering care. The response will link to and build upon existing child and family services within the broader system providing an enhanced continuum of care, provide better support, and achieve measurable outcomes.

The FPR Senior Practitioner role is critical in implementing a wrap around, evidence informed case management approach for the most complex challenging families. The Family Preservation and Reunification (FPR) team will work in close partnership with the identified partner agencies. The FPR Response will be culturally safe and utilise a relational approach that is adaptable and responsive to family and individual needs and key case management frameworks. The work is strengths based, child and family centred, integrating intensive assessment, care team planning, safety and risk planning and parenting strategies to promote resilience and self-determination.

The Response will provide staff training to build capability and ensure model fidelity. This will involve online training, coaching sessions, support for teams.

## **Family Preservation & Reunification Practitioner**

The Senior Practitioner Adolescents will work closely with the Team Leader to provide support and live coaching to FPR Practitioners in cases that are high risk, present multiple demands and when FPR Practitioners identify as needing additional support. The Senior Practitioner will also supervise and support the Youth Support and Advocacy Practitioner and undertake Higher Duties during the Team Leader's leave.

#### 4. Key responsibility areas

#### **Service delivery**

- Delivery of the Family Preservation and Reunification Response providing a rapid, intensive, wraparound response to meet the safety and developmental needs of children/young people and support the needs of parents.
- Delivery of intensive case management based on the FPR Response Guidelines and Best Interest Principles as defined under the Child, Youth & Families Act 2005 with an understanding of how this is integrated within evidence-based programs.
- In conjunction with the Team Leader provide live coaching and support for FPR Practitioners and direct reports in outreach activities, care team meetings and complex tasks in cases that are high risk, have multiple needs and when Practitioners identify they need additional support.
- Provide supervision, case consultation and support to direct report/s in all areas of service delivery.
- Undertake Higher Duties as requested
- Work within a culturally safe framework in partnership with family members, specialist and universal service providers utilising principles of the Aboriginal family led decision making and self-determination.
- Work within the prescribed relational model of connecting and linking families to build safety and empower and create meaningful opportunities that build upon their strengths utilising a range of evidenced informed intervention strategies including the Common Elements
- Work intensively with children young people and families to support family preservation and reunification in line with the Child Protection case plan and Care Team
- Demonstrate assertive outreach and creative engagement solutions with hard-to-reach families; provide outreach at flexible times with families based on their needs
- Maintain effective risk assessment to regularly assess child and young people's safety concerns and engage with other professionals to support the safety planning for children, young people and family members.

## **Family Preservation & Reunification Practitioner**

- Establish and lead care teams in line with the agreed action plan.
- Strengthen the family's connection to community by meaningful engagement with community supports that will sustain the family over time and be culturally appropriate.
- Access and utilise specialist resources and evidence informed frameworks that address the complex needs of family members including Family Violence, Drug and Alcohol, Mental Health, Disability and the impact of Trauma.
- Identify and connect with networks and services that have a focus on adolescents
- Work collaboratively with Child Protection
- Provide families and young people with practical and emotional support, advocacy, coaching, skill building and connection to social and economic resources
- Prepare reports, service documents and maintain accurate and up-to-date client records and case notes
- Actively seek out the voice of the child and young people, advocating for their voice to be heard
- Identify opportunities for financial assistance and brokerage for families
- Participation in the afterhours on-call roster for FPR service users
- Other duties as required

#### Quality and risk

- Participate in regular supervision with Team Leader
- Undertake designated training in the Response model and adolescent specific intervention models to contribute to implementation of service delivery models in conjunction with the Team Leader.
- Maintain accurate and up-to-date case notes, family care and action plans and data
- Ensure direct reports deliver services in line with program requirements and agency guidelines, ensuring maintenance of case records, risk assessments and individual client action plans to a high standard.
- Participate in relevant meetings, panels and consultations
- Support and participate in the Agency's continuous quality improvement process.
- Participate in team reflective practice
- Participate in the development of individual Performance Development Plans
- Ensure the highest quality of service provision through a commitment to organisational values, policy and procedure adherence, and maintenance of positive relationships with key stakeholders.
- Support the focus and further development of practice with young people that addresses both their identified needs for family/community connection as well as their individual development.

#### Personal accountability

- Compliance with Uniting's values, code of conduct, policies and procedures and relevant government legislation and standards where relevant.
- Cooperate with strategies to actively ensure the safety, protection and well-being of children who come into association with us.
- Ensure appropriate use of resources.
- Work collaboratively with Uniting (Victoria Tasmania) employees and external stakeholders in accordance with Uniting's values and professional standards of behaviour.
- Actively participate in initiatives to maintain, build upon and promote a positive and collaborative workplace.

- Well-developed written and verbal communication skills, including the ability to prepare for and conduct meetings and implement agreed actions
