Overview of program and position

The purpose of Anglicare Victoria's Family Services Program is to strengthen families' capacity to meet the needs of their children. Family Services promotes the safety and wellbeing of children by supporting and empowering families to enhance parenting capacity and family functioning and therefore improve child outcomes.

Many of the families the program works with have long histories of involvement with both Child Protection and community agencies. As a result, they require flexible and innovative interventions to address multiple and complex needs, and to promote the best social, emotional, educational and health outcomes for their children. The service targets families with children newborn to 18 years living in the North East Metro Region, which comprises the LGAs of Banyule, Darebin, Nillumbik, Whittlesea and Yarra. In the North Eastern Metro Region, Family Services is delivered in the context of the North East Metro Child and Family Services Alliance, which is an alliance of nine agencies and DHHS.

This position involves working with a caseload of families consisting of a combination of families referred to Integrated Family Services (110 hrs) and families referred to Intensive Family Services (200 hrs approach).

- 1. Integrated Family Services provides families with case management support within a managed case plan, designed to improve the lives of children. Individual family work is complemented by group work where appropriate, as well as strategies to both engage families with their communities, and for communities to be more responsive to the needs of children and their families. Most referrals are from the Orange Door which is the central intake point for families needing assistance with the care and wellbeing of children in the North East Metro Region.
- 2. Intensive Family Services is provided to families whose children are subject to a Family Preservation or a Family Reunification Order. Referrals are from DHHS Child Protection. Family Services works in partnership with DHHS Child Protection (and other services where required) for up to 200 hours, working collaboratively and effectively with families to achieve Child Protection case plan goals. Child Protection retains case management responsibility. Practitioners support families to meet case plan goals by promoting child safety, stability and development, as well as increasing parenting capacity and family functioning. Practitioners have a reduced caseload of Intensive Family Services cases in recognition of the level of contact with each family.





Position Objectives

1.	Provide an in-home family casework service, working in partnership with families to achieve their goals aimed at enhancing children's development, parenting capacity and family functioning.
2.	Take steps to reduce risks to children's health, safety and wellbeing and that of other family members.
3.	Work with families to empower them to manage their life situation, including having a positive engagement with their community.
4.	Participate in group work, advocacy and community development as required.





Key responsibilities

The key responsibilities are as follows but are not limited to:

1.	Provide case management to clients and respond to their needs through assertive outreach and responding to crises that occur. Use a range of therapeutic techniques and approaches to engage with children, young people and families who are reluctant or ambivalent about using support services.				
2.	Conduct comprehensive family assessments that identify the health, wellbeing and safety needs of the children involved, and that identify both the capacity and constraints of the families to make necessary changes.				
3.	Establish a working relationship with children, young people and families which demonstrates respect and honest communication, particularly about protective concerns and consequences.				
4.	Strengthen family connections, promoting positive interactions and the health, wellbeing and safety needs of children, young people and families.				
5.	Promote positive parenting skills through working with families individually as well as providing group work as required.				
6.	Work collaboratively with DHHS Child Protection, other professionals and families' broader social networks to ensure a coordinated approach to services for children, young people and their families.				
7.	Make an active commitment to the development and maintenance of a cohesive multi-disciplinary team and participate in staff meetings, team meetings and staff development training.				
8.	Fulfil requirements regarding case records and data recording. Participate in professional development activities appropriate to the position. Undertake other duties within capability as directed from time to time.				





Key Selection Criteria

The Key Selection Criteria are based on role specific requirements **and** the Anglicare Victoria Capability Framework. Applicants are required to provide a written response to **both** a) and b).

a) Role specific requirements

Applicants are required to provide a written response to the role specific requirements. The five criteria are to be addressed individually (no more than 2 pages in total).



- 1. A relevant degree in Social Work, Psychology, Early Childhood Specialist and/or a related degree in behavioural sciences with a minimum of two years relevant experience.
- 2. Demonstrated resilience to work with and support clients who have been exposed to trauma, violence or neglect.
- 3. Demonstrated awareness and commitment to working within the 'Best Interest Principles' outlined within the *Child, Youth and Families Act 2005* and a sound understanding of the Victorian Child Protection system.
- 4. Demonstrated experience working with families who have multiple and complex needs, utilising a child-focused family-centred approach.
- Demonstrated understanding and application of individual and systemic theories which underpin effective in-home family based interventions.
- Demonstrated ability to work collaboratively with a diverse range of stakeholders, including DHHS Child Protection, to reach the best outcomes for children, young people and families, including a demonstrated awareness of the Child Information Sharing Scheme, the Family Violence Information Sharing Scheme and the MARAM Framework.
- Demonstrated computer skills in Microsoft Office packages and other statistical databases such as IRIS.

Key Selection Criteria (continued)

b) Anglicare Victoria Capability Framework
