Alcohol & Other Drugs Services

Anglicare Victoria's Alcohol and Other Drugs (AOD) services operates via a number of programs which aim to reduce harm and prevent relapse. Our trauma-informed employees meet young people, adults and families where they are at in their journey and work to support safety, understanding and compassion for everyone involved in the recovery process. We provide counselling, consultancy and continuing care to individuals using substances; families and friends of individuals using substances; individuals currently involved in the criminal justice system and professionals needing assistance in working with and supporting individuals using substances. We also work with families to support the Reunification Program, which provides counselling, consultancy and continuing care to parents whose children are subject to Family Reunification Order, children who are impacted by the Family Reunification process, working in collaboration with Child Protection from a shared care approach and providing assessment and ongoing treatment for parents, their children and family members under a Family Therapy model.

Qualifications/Licences

Required:

- Tertiary qualifications to Bachelor or Diploma level in Social Work, Psychology, Counselling or Behavioural Sciences or equivalent.
- Cert IV in AOD or Post Graduate Certificate in AOD, including Dual Diagnosis competencies.
- Full Victorian Drivers Licence

Knowledge and skills

- Highly developed knowledge and experience in working with practice models of contemporary counselling approaches in the alcohol and drug field.
- Significant clinical experience and demonstrated competence in application of theory and practice techniques in therapy with families, with specific emphasis on adolescents and their parents.
- Experience in Family Reunification and demonstrated ability to work with mandated clients.
- Understanding of the principles of harm minimization and approaches to the treatment of AOD substance use including relapse prevention.
- Understanding of the developmental needs of young people and ability to work with them in the context of family and social attachments.
- Demonstrated experience and skills in developing co-operative partnerships with agency workers and community services
- Highly developed communication skills (written and oral) to manage both internal and external stakeholders.
- Ability to advocate for and promote best practice in AOD services.
- Demonstrated ability to be receptive and flexible to new ideas and the capacity to adapt to changing work demands and circumstances.
- Ability to mentor and support less experienced AOD employees.
- Excellent computer, organisational and time management skills and the ability to be self-directed, whist working within a team.
- Ability to listen, problem-solve and resolve conflicts through well-developed conflict resolution skills.
- Ability to self-reflect, take on board feedback, and use supervision opportunities to improve one's practice and leadership.


• **Drive and commitment:** ability to lead with best practice and set a high standard; motivated and positive approach to new challenges.

Your Contribution (responsibilities)

The key contributions in the role are outlined below:

Role specific

- Delivering counselling services to clients via outreach.
- Conducting comprehensive intake and assessments including mental health screens and MARAM assessments.
- Managing a case load, as assigned, to support young people and families to reduce young people's problematic substance use and associated harms.
- Improving long-term treatment, health and well-being outcomes for young people with substance use issues by improving treatment engagement, retention and family functioning.
- Improving the management of relapse through improved support for young people.
- Engaging clients in cooperative and goal-directed working relationships and assisting them to achieve
 positive outcomes by implementing an Individual Treatment Plan to specifically meet the client and/or
 family needs, including implementation of short-term case management strategies, facilitating entry
 into other AOD services where appropriate and maintaining continuity of care across service systems.
- Responding appropriately to co-morbidity of substance use and mental health problems, while using a Family Therapy approach, engaging with young people and their families to address problematic substance use.
- Improving family engagement in young people's treatment of substance use.
- Encouraging family members to explore and map their extended families and social networks in order to develop broader informal support systems.
- Assisting the family to identify additional sources of support inside and outside the family that will sustain positive changes in the family system.
- Undertaking group facilitation as per service requirements including preparation, delivery and review.
- Contributing to and participating in research to evaluate the LYFT program and to build evidence in support of a Family Therapy model that can be applied broadly across the State.
- · Actively contributing to the development of the service model.
- Establishing co-operative and effective relationships with partner organisations and other AOD Service, Community Groups and Health organisations to support positive outcomes.
- Building the capacity of the Victorian specialist Alcohol and Drug Services to develop integrated family responses as part of their work with young people. Working within a harm minimisation framework.
- Being an active lead in external stakeholder meetings as a senior representative of Anglicare Victoria (AV) when required.
- Maintaining confidential client case notes to ensure effective case management and therapeutic intervention.
- Maintaining up to date records, the relevant data collection methods and management which all alcohol and drug services are mandated to keep and assist the Team Manager and Program Manager to review and evaluate program performance on a regular basis and support administrative duties as required.
- Participating in relevant training to extend and expand professional therapeutic skills.
- Participating in team development, peer and clinical supervision and the articulation of a Family Therapy treatment model that can be transferred to a state-wide application.

Our Commitment to Child Safety

Employment Screening and Required Certificates

Anglicare Victoria conducts safety screening practices for all preferred applicants. Safety screening must be satisfied prior to formal offers of employment being made and must be kept current to ensure ongoing employment. These include but are not limited to:

- an Australian Criminal History Check,
- an International Criminal History Check for those who have lived outside of Australia for longer than 12 months within the last ten years,
- a Current Employee Working with Children Check,
- In line with Anglicare Victoria's Covid 19 Vaccination Policy all staff, students and volunteers are required to provide evidence of full vaccination against Covid-19 or provide a valid medical exemption. This requirement may be amended from time to time in line with Anglicare Victoria Policy or as directed by Chief Health Officer.
