Overview of program

The Department of Health and Human Services' Road Map for Reform is focused on strengthening and connecting the child and family service system. This means moving away from individual programmatic approaches to service delivery towards seamless pathways across the service system that is responsive to the needs of children and families. Below is a visual representation of the reforms:

three pathways to support, connected to community and delivered by a service network



1. Early Help. 2. Targeted and specialist support. 3. Continuing Care

Using the experience and expertise that exists in the region, a team has been developed consisting of Anglicare's Placement Prevention and Reunification programs (Stronger Families, Families First, Intensive Family Services and Targeted Care Packages). This multi-disciplinary team will work together to operationalise the reforms so children and families receive seamless support as they move across the pathways. This team will deliver a range of interventions from family support for children at risk of entering the child protection system, placement prevention and reunification, targeted care packages and Stronger Families, Families First and Intensive Family Services.

This Team Leader position will develop, lead and supervise a multi-disciplinary team. This complex and exciting opportunity will allow for innovation, learning, trialling new approaches, integrating evidence informed practice frameworks and delivering a seamless service model. The Team Leader must have an excellent understanding and experience in delivering services across the child and family service system and be able to develop practice in a way new to the sector.

Position Objectives

1.	To co-ordinate the delivery of a high quality program that provides genuine and positive outcomes for clients.
2.	To work in conjunction with the Program Manager to plan and implement responses in relation to sector and service developments.
3.	To ensure appropriate processes are in place to enable continuous improvement of services and to promote best practice and ongoing quality improvement of the program.
4.	To ensure the program is operated in accordance with service and quality standards, program targets, DHHS and related service agreements, organisational policies and accepted standards of practice.
5.	To provide ongoing support, supervision, performance management, learning and development of team members in this program.

Key responsibilities

The key responsibilities are as follows but are not limited to:


1.	Ensure the delivery of program services meets client requirements and is in accordance with the service agreements and within program budget requirements.
2.	Monitor performance targets, outcomes, quality standards in service agreements, legislative and policy requirements, issues of quality of care issues, reportable conduct and complaints.
3.	Monitor program performance and outcomes through the collection and analysis of service data and implement changes to the operation of the program.
4.	Participate in the development and maintenance of quality partnerships with key agencies including the Victorian Government Department of Human Services (DHHS) and other community services providers.
5.	Participate in the professional development and recruitment of staff, including supporting a culture of reflective practice, quality supervision and coaching.
6.	Initiate and implement service improvements and participate in service redevelopment and redesign.
7.	Contribute to the preparation of the program budget and work with the Program Manager to maintain accountability for the program budget and implement corrective action as required.

Key Selection Criteria

The Key Selection Criteria are based on role specific requirements **and** the Anglicare Victoria Capability Framework. Applicants are required to provide a written response to **both** a) and b).

a) Role specific requirements

Applicants are required to provide a written response to the role specific requirements. The five criteria are to be addressed individually (no more than 2 pages in total).

 <p>Role Specific</p>	1. Tertiary qualifications, preferably in social work, psychology or behavioural sciences or equivalent.
	2. Excellent understanding of the Child Protection, OOHC placement and support services and family service system, including legislative and policy framework.
	3. Excellent knowledge of, and experience in the application of relevant theoretical approaches that underpin casework practice (including theories of child attachment, development and abuse) to vulnerable children, young people and families.
	4. Well-developed skills and experience in delivering programs and services within required timeframes and budget parameters.

Key Selection Criteria (continued)

b) Anglicare Victoria Capability Framework

Applicants are required to provide a written response to the Anglicare Victoria Capability Framework. Applicants are to describe how they demonstrate the characteristics in each of the three nominated capability groups; **Personal Qualities**, **Relationship and Outcomes**, and **Leading People** (no more than 1 page in total).

The Anglicare Victoria Capability Framework describes the capabilities required to meet the expectations of clients, colleagues and communities in today's changing environment.

These capabilities work together to provide an understanding of the knowledge, skills and abilities required of all employees.
