POSITION PURPOSE

The Safe, Sustainable, Accessible Rail (S²AR) GRIP Coordinator supports the GRIP Directors in the delivery of the GRIP's strategy and operations; and manages and co-ordinates the day to day operational activities of the newly formed GRIP.

The GRIP Coordinator will be responsible for coordinating the processes of PhD candidate applications through to offer. The Program Coordinator will work closely with the lead Faculty Graduate Research Office to coordinate and manage the Expression of Interest (EOI) process. The position requires liaison with industry partners, such as internship periods and the incumbent governance and compliance criteria are met.

The S²AR GRIP Coordinator will support the supervisors and co-directors in ensuring University and Industry requirements are met with respect to the PhD projects, which embodies the innovation/research program of the S²AR GRIP. The GRIP Coordinator will also coordinate innovative training programs on business and technical topics that enhance skills for the PhD students enrolled in the S²AR GRIP Program. The role will require the organisation of GRIP launch events and GRIP workshops that take place in a regular basis to bringing key stakeholders together for a meet and greet and for knowledge sharing with industry partners. The Program Coordinator will be part of the S²AR GRIP management team.

Reporting Line: The position reports to one of the S²AR GRIP co-directors based within Monash IRT and also may take broad directions from the S²AR GRIP co-directors and Monash IRT Director.

KEY RESPONSIBILITIES

 Contribute and co-ordinate the operations and stakeholder management of the S²AR GRIP program, including progress reporting to Monash, industry and other stakeholders, facilitating relationship development with partner industries, and reporting to the S²AR GRIP Management Team and the GRIP Advisory Board

- 2. Liaise with academic research supervisors, and the Monash University Graduate Research Office to support the delivery of the research and PhD Training of the S²AR GRIP program
- **3.** Operational financial management, budgeting and reporting for the S²AR GRIP, within the framework of Monash University policy and practice
- 4. Foster a culture of collaboration, networking and information exchange by coordinating the S²AR GRIP knowledge transfer and skill sharing (seminars, workshops, site visits and other forums), including S²AR GRIP launching events and other events that promote or enhance the GRIP stature, in conjunction with relevant stakeoholders
- **5.** Liaise and track applications from advertising and marketing through the Eol process, interviews and on-boarding of candidates
- 6. Liaise with industry partners and PhD candidates, co-ordinate industry placements, have oversight of all compliance requirements of the Monash PhD as pertinent to different faculty requirements
- 7. Provide the signed contracts with industry to the relevant faculty/academic units along with the cost centre and fund required for processing the scholarship payment at the time of enrolment
- 8. Advise the GRIP Directors and supervisors of candidate progress and or issues that arise during candidacy
- **9.** Coordinate resourcing of workspaces and equipment needs on campus for candidates. Liaising with e-solutions and any OHS and security requirements
- **10.** Maintain an effective working relationship with key Monash IRT, business units, functional areas, Faculties and University staff including those from the Monash Graduate Research Office
- **11.** Advocate and promote S²AR GRIP, communicate outcomes, engage collaborators, stakeholders and interested third parties to profile the success and impact of the GRIP, in order to extend the Program and advance future growth opportunities
- **12.** Other duties as directed from time to time.

KEY SELECTION CRITERIA

Education/Qualifications

- 1. The appointee will have:
 - A tertiary qualification and/or exposure to post graduate education and extensive, relevant experience;
 - extensive experience and proven expertise; or
 - an equivalent combination of relevant experience and/or education/training.

Knowledge and Skills

- 2. Experience implementing strategic plans through strong operational business management of programs and projects
- **3.** Demonstrated experience within industrial research and/or university research context, including expertise in project management and a strong understanding of Intellectual Property
- 4. High-level interpersonal skills and proven ability to establish a good working relationship with colleagues and students and to develop and maintain strong professional links with relevant industry and the community
- **5.** Proven ability, commitment and passion for engaging in academic and research activities, taking a leadership role where appropriate

- 6. Ability to plan, organise and achieve work targets, sometimes in demanding circumstances and work harmoniously and constructively with academic colleagues and other University staff
- **7.** Ability to promote the S²AR GRIP and Monash IRT both within the University and to the greater community
