ROLE CONTEXT

Primary Objective(s) of role:
<p>The CALHN Heart & Lung program – Cardiology Service, provides nursing services within current nursing models of care focussing on patient centred acute inpatient services both life-threatening or potentially life-threatening conditions - emergency and elective; including cardiac diagnostics and interventional and electrophysiology procedures and Cardiac Rehabilitation and Heart Failure and outpatients. The Cardiology nursing service extends to management of the Cardiothoracic Surgery wing and pre operative service</p> <p>4Ew1 is a 16 bed Coronary Care Unit with 6 beds being 1:2 nurse:patient ratio and the remaining 10 beds 1:3. RN's are encouraged to have Advanced Life Support Skills.</p> <p>Education opportunities on 4E1:</p> <p>Registered Nurses commencing in CCU will be supported with an individualised learning/training program supported by senior CCU nurses and cardiac nurse specialists. An 11 week (2 hours/wk) Cardiac Rhythms course is provided, followed by a High Acuity course led by our Heart and Lung educators over 20 weeks. Other education opportunities include weekly nurse focused education run by Cardiologist and Cardiothoracic Consultants.</p> <p>The Registered Nurse level 1 develops from a novice practitioner to a proficient level of professional practice. They consolidate knowledge and skills and develop in capability through continuous professional development and experience. The Registered Nurse enables patient involvement in their treatment plans and is an integral component of the cardiology nursing workforce. The Registered Nurse accepts accountability for his or her own standards of nursing care and for activities delegated to others.</p>
