POSITION PURPOSE

A Senior Lecturer (Level C academic) in the Faculty of Law is expected to make significant contributions to the teaching efforts of the University and Faculty, especially in the core law units in the curriculum, such as Administrative Law, Company Law, Contracts, Criminal Law, Property Law, Trusts, Equity, Intellectual Property Law, and Litigation & Dispute Resolution. An academic at this level is also expected to play a major role in scholarship, research and professional activities.

Reporting Line: The position reports to a senior academic, working under broad direction, with a degree of autonomy

KEY RESPONSIBILITIES

Specific duties required of a Level C academic may include:

- 1. Preparation and delivery of teaching activities (including seminars, tutorials, practical classes, demonstrations, workshops, and clinical sessions), and consultations with students
- 2. Leadership in legal education and curriculum development, particularly in the core curriculum
- **3.** Course coordination, including offering guidance to assistant lecturers and supervision of sessional staff in teaching unit/s if required
- 4. Supervision of PhD, honours and postgraduate research students
- 5. Preparation of assessments and marking of student work
- **6.** Active contribution to the development of the Faculty's research agenda and the conduct of research, including high quality publications and contribution to the preparation or where appropriate, individual preparation of research proposal submissions to external funding bodies
- 7. Playing significant roles in research projects including, where appropriate, leadership of a research team
- 8. Involvement in professional and engagement activity
- **9.** Participation in and leadership of Faculty administrative matters, including committees, course program management and other administrative roles as required
- 10. Working in a collegial manner with other staff in the workplace
- 11. Other duties as directed from time to time

KEY SELECTION CRITERIA

Education/Qualifications

- **1.** The appointee will have:
 - A doctoral qualification in the relevant discipline area or equivalent accreditation and standing
 - In determining experience relative to qualifications, regard shall be had to teaching experience, experience in research, experience outside tertiary education, creative achievement, professional contributions and/or contributions to technical achievement. In addition, a position at this level will normally require a record of demonstrable scholarly and professional achievement in the relevant discipline area.

Knowledge and Skills

- 2. Proven ability, commitment and passion for engaging in scholarly and research activities
- **3.** Demonstrated publication record in high quality referred journals, conferences, equivalent books or teaching resources
- 4. Demonstrated ability in undertaking outstanding research and leading a research team and projects, and proven record of obtaining external grants for research
- 5. Demonstrated record of successfully supervising postgraduate research students
- 6. Ability to work positively and cooperatively with staff, students, internal and external teams and external organisations

- **7.** A high level of interpersonal skills and demonstrated ability to work independently and as part of a team across both the education and service sectors
- 8. Demonstrated strong record of teaching experience in core law curriculum units (including the capacity to teach in Australian law) in a tertiary environment, including course and unit coordination.
- 9. Demonstrated ability to motivate, actively engage and educate a given audience
- **10.** Demonstrated experience and willingness to contribute to Faculty committees, leadership and administrative roles
- **11.** A demonstrated capacity to work in a collegial manner with other staff in the workplace
