Overview

Deakin's Research Business Development and Commercialisation division (BD&C) is a key function within the University's Research and Innovation portfolio, establishing partnerships with industry, government other public and private sector organisations and our community; and positioning Deakin as a leader in research translation. Dedicated to developing partnerships, business development, the division is responsible for steering the strategic vision and positing Deakin as a partner of choice, connecting researchers with opportunities and managing external engagement. The team also bring innovative solutions to market through commercialising Deakin's intellectual property and supporting entrepreneurs through our Spark program. BD&C key areas within the division are Deakin's Recycling and Clean Energy Commercialisation Hub (REACH) Trailblazer, Business Development, Intellectual Property, Commercialisation and Entrepreneurship.

The Senior Consultant, Business Development is part of the Business Development and Commercialisation division. In collaboration with key stakeholders, the Senior Consultant will take a hands-on and proactive approach to identify and deliver new research relationships to achieve a more sustainable, efficient and improved university.

The primary purpose of the Senior Consultant, Business Development role is to work closely with the Associate Director, Business Development to provide high-quality, thorough and responsive support to University's externally-funded research activities across all campuses according to Deakin processes to ensure compliance with University objectives and policies.

The incumbent will support the Business Development and Commercialisation team to develop linkages with industry, government and other public and private sector organisations to support research and development at the University. The incumbent will assist Associate Director, Business Development in developing new strategies and initiatives for growing research activities, raising research income, and manage these activities, including assisting in the identification of opportunities for research funding from non-traditional sources. Business Development and Commercialisation has the central responsibility for developing and managing major research proposals and commercialisation potential with the exception of nationally contestable grants and will work closely with other members of the research teams in the Division.

Reporting to the Director, REACH Industry Engagement, the role will:

- Lead with clear direction high-quality end-to end preparation of research agreements and proposal costing
- Build strong professional relationships with Deakin researchers and a strong understanding of their research focus' and activity to identify and foster research relationships for Deakin and provide strategic advice as to how to best align Deakin research with industry, government and not-for-profit needs.
- · Maintain strong relationships with research partners to ensure there is pipeline of opportunities
- · Position Deakin as a major player in research and a preferred research provider through external networking.
- · Record, monitor and circulate potential external funding opportunities in the fields University has the capability and expertise
