## ABOUT THE OFFICE OF THE DEPUTY VICE-CHANCELLOR, COORDINATION

Established in February 2019, the Office of the Deputy Vice-Chancellor, Coordination is a new University portfolio which, among other key responsibilities, plays a major part in extending ACU's Catholic intellectual and ethical capacity. The Office of the Deputy Vice-Chancellor, Coordination, comprises ACU's Core Curriculum, the University's Associate Vice Chancellors and Campus Deans, and certain Institutes and Centres that support the University's contribution to Ethics, including; the PM Glynn Institute, the Institute of Child Protection Studies, the Plunkett Centre for Ethics and the Queensland Bioethics Centre.

The major areas of responsibility for the Office of the Deputy Vice-Chancellor, Coordination, encompass: maintaining institutional unity as well as campus diversity across a multi-state, multi-campus university; developing a national approach to Catholicity by coordinating Catholic intellectual life and cultural dialogue with the secular world, extending to both student and staff formation; and coordinating and overseeing changes to organisational structures to achieve organisational direction in line with the Vice-Chancellor's priorities.

The Coordination Portfolio has the lead responsibility of increasing ACU's national Catholic ethical capacity and improving the Core Curriculum. There are several initiatives aimed at resourcing, forming, and teaching a variety of internal (staff and students) and external groups and communities on ethics related topics.

## POSITION PURPOSE

The position sits within the Office of the Deputy Vice Chancellor, Coordination.

The Lecturer (Academic Development – Ethics) will assist the Senior Manager, Operations and Programs, within the Office of the Deputy Vice-Chancellor, Coordination, in implementing the ACU Ethics Strategy through the newly founded *Ethics Hub* and through the Core Curriculum.

The Ethics Hub will provide formation opportunities, public programming, intensive seminars, and a wide range of digital ethics-related resources for ACU staff, students and the wider community. It aims to raise the profile of ACU as the nation's leading hub of Catholic ethical thought, activity, and advice.

Areas of focus include, but are not limited to: 1) leading the intensification of ethics in the Core Curriculum through ongoing curriculum review, revision, improvement and support of innovative online delivery, 2) leading scholarly activities and methods for resourcing, collating and curating high quality intellectual resources across the web (links to articles, videos, books, Church teaching) for a web-based ethics resource and for the Core Curriculum, and 3) leading the planning, coordination, and teaching, of a variety of ethics-related intensive formation seminars and programming in *The Ethics Hub*.

The role will report directly to the Senior Manager, Operations and Programs, Office of the Deputy Vice-Chancellor, Coordination, with additional indirect reporting to the Core Curriculum Lead Academic. The position will work closely with the Core Curriculum Lead Academic and Core Curriculum Faculty Liaisons. The Academic Lecturer (Ethics) will work collaboratively to support teaching projects, writing and editing project deliverables, and collation of data relating to the major areas of focus within the portfolio, to further the work of the Office of the Deputy Vice-Chancellor, Coordination, and the Core Curriculum.
