# **Mental Health Program**

The Monash Health Mental Program provides inpatient and community-based services to people of any age with a mental illness and those with alcohol or other drug problems. The Early-in-Life Mental Health Service (ELMHS) provides care for children and youth up to 25 years of age; the Adult Mental Health Services for people up to 65 years; and the Aged Persons Mental Health Service for people over 65. In addition there are a range of specialist and all-age services – consultation-liaison psychiatry, primary care mental health, drug and alcohol services, psychiatric triage service, agile psychological medicine clinics, wellness and recovery centre (for eating disorders), perinatal and infant psychiatry, gender dysphoria clinic and neurodevelopmental disorders. Services are provided by a range of health professionals, working in multidisciplinary teams including counsellors/welfare workers, medical officers and registrars, mental health nurses, occupational therapists, psychiatrists, psychologists, social workers and speech pathologists, supported by administrative and ancillary staff. The catchment area for Monash Mental Health Services covers a wide area of south-east metropolitan Melbourne with a population of around one million people. Monash Health operates 106 beds in acute adult psychiatry, 20 child & adolescent beds (Stepping Stones), 40 acute aged person's beds, 50 secure extended stay beds, 40 community residential rehabilitation beds, 50 prevention and recovery beds (medium stay, low security), and 12 drug and alcohol withdrawal beds. These inpatient services are supported by an extensive community program.

Of particular relevance to this position, is the exciting development at Monash Health of the new Monash Children's Hospital, opened in 2017. This will provide greater opportunity than previously to integrate mental health services for children and adolescents into mainstream child health programs. Of particular note is the development of a new children's neuropsychiatry inpatient unit within Monash Children's, which will provide specialist assessment for children under 12 years of age experiencing complex and severe neurodevelopmental and psychiatric problems. In addition, the Early in Life Mental Health Service provides community based clinical services across our region; Monash, Dandenong and Casey/Cardinia, for people with developmental and neuropsychiatric problems and first episode psychoses, as well the common childhood psychiatric disorders.

Monash Health Mental Health prides itself in its postgraduate psychiatry training program, with over 50 trainee psychiatrists rotating through all stages and clinical areas of training.

The school's researchers collaborate closely with relevant clinical areas in the hospital and in many cases hold senior clinical positions. Researchers also liaise closely with the Hudson Institute of Medical Research which is located on site and forms a Department of Molecular and Translational Sciences in the school, as well as other parts of the University and external research organisations.

The school is a key partner of the Monash Institute of Medical Engineering. In 2015 the School's researchers published >800 papers, and had >190 PhD students enrolled, and generated ~\$30M in research funding. In addition, the School of Clinical Sciences hosts multiple University Research Centres (including CDPP). The **Department of Psychiatry** is a Department of the School of Clinical Sciences at Monash Health, which provides academic leadership in teaching and research embedded within the University's activities at campuses of Monash Health. In partnership with Monash Health it runs a strong postgraduate psychiatry training program.

The Department of Psychiatry has strong research units in Developmental Psychiatry and Psychology, Aged Persons' Mental Health, Consultation-Liaison Psychiatry, Molecular Pharmacology, Psychiatric Epidemiology and Health Services Research, and Clinical Trials. The Centre for Developmental Psychiatry and Psychology is one of these research units.

# The Centre for Developmental Psychiatry and Psychology

The Monash Centre for Developmental Psychiatry and Psychology (CDPP) was established in 1989 as a joint clinical research and teaching centre of Monash University and Monash Health. It has a vision to be Australia's leading clinical research centre in developmental psychiatry and psychology. Its foundation professor was Emeritus Professor Bruce Tonge. The CDPP has developed outstanding research in two major streams: 1. The psychopathology and treatment of developmental disabilities (intellectual disability, including autism); and 2. The phenomenology and treatment of emotional (internalizing) disorders such as depression and anxiety. It also has major undergraduate and postgraduate teaching programs, including a successful child psychotherapy training stream within the Masters of Mental Health Science degree. It collaborates with Mindful, the State CAMHS workforce training program, as well as contributes to government policy development, service delivery and professional and consumer / carer organisations. The CDPP works in close affiliation with the clinical services provided by Monash Health as well as CAMHS in Bendigo, Mildura, Barwon, Wangaratta, and the LaTrobe Valley. These links provide a substantial base of patients who form the focus of the range of clinical research projects.

# **Position Summary**

Monash Health and Monash University have a joint vision to continue the development of Developmental Psychiatry and Psychology as a clinical and academic strength, serving the community through advanced treatments and interventions and education programs. The **Professor and Director** will be responsible for the academic leadership and strategic development of developmental psychiatry and psychology, working alongside the Unit Head of ELMHS to develop a first-class clinical academic service at Monash Health consistent with our Strategic and Clinical Services plans.

The appointee will be a member of the Senior Medical Staff of Monash Health and fulfil a senior and significant clinical leadership role within Monash Health, providing clinical work in their area of interest and expertise – in an area of child and adolescent or youth psychiatry.

The appointee will be a **Professor of Monash University** and a member of the School of Clinical Sciences at Monash Health, Faculty of Medicine, Nursing and Health Sciences. The appointee will lead, foster and grow excellence in research in the discipline of psychiatry. The appointee will develop and maintain a research program that is fully integrated with that of Monash Health, MHTP etc. The appointee will be responsible for developing a world-class research program as evidenced by publications in high impact journals, success in peer review funding schemes, international standing and/or translational achievement. Relevant fields of research for the appointee are broad and include clinical or basic research relevant to psychiatry.

The appointee will be responsible for leadership of the undergraduate and postgraduate teaching programs within the field of developmental and child and youth psychiatry.

The appointee will report to:

- 1. The **Program Director, Mental Health, Monash Health**, for provision of clinical services, management of any budget for clinical services they direct, and professional governance, research and education
- 2. The **Head, Department of Psychiatry, School of Clinical Sciences at Monash Health** for research, teaching and administrative duties relevant to Monash University

#### **Objectives**

The appointee will be responsible for:

- Clinical leadership in an area of specialty within developmental or child and adolescent psychiatry, to achieve optimal service provision, best practice patient outcomes, and strengthening of professional, educational and research activities; The particular area and scope of leadership will depend on the interests and expertise of the successful candidate, though it is expected the person will have a senior leadership role in the Early in Life Mental Health Service
- Strengthening and expansion of research and teaching in developmental psychiatry and psychology at Monash Health and Monash University
- Leadership of the Centre for Developmental Psychiatry and Psychology in a way that enhances its world-wide reputation
- Leading initiatives in undergraduate and postgraduate teaching relevant to developmental psychiatry and psychology (for instance, in undergraduate medicine and postgraduate psychiatry)
- Enhancing the translational research activities of Monash Health, Monash University and their partners

- A Working with Children's Check certificate

- A long record of outstanding clinical care as a psychiatrist caring for the mentally ill in inpatient, outpatient, community and a range of other settings

- Experience in development or refinement of courses and course materials for undergraduate and postgraduate students
- Experience in development and delivery of course materials for use in medical and psychology professional curricula
