Position Summary

The Australian Centre for Architectural History Urban and Cultural Heritage (ACAHUCH) hosted within the Faculty of Architecture, Building and Planning requires a Research Assistant to work on a project titled “Evaluating Online Explorations of World Heritage through Google Search Culture”.

This research project investigates the how searching on Google’s various services are changing the way people experience World Heritage, and conversely, what the data captured by Google through people’s online search queries, can tell us about people’s connection to these important places. The research phases combine quantitative data analytics, content analysis and qualitative digital and rapid ethnographies.

The Research Assistant will perform a range of research-related activities including: conducting literature searches, assisting in digital ethnographies, carrying out data analytics, collecting, managing and analysing data and preparing reports in English and French.

1. Key Responsibilities

- ▶ Conducting and writing literature reviews in English and French.
- ▶ Assisting in data collection, management in English and French.
- ▶ Ethnographic analysis of digital data in English and French.
- ▶ Data Analytics and Content Analysis.
