Charles Sturt University is a community minded organisation with strong links to industry, government and other educational organisations through research and courses. Our vision is to be Australia's leading regional university, advancing the careers of our students, inspiring research excellence and driving regional outcomes with goal impact. We collaborate with our partners on research with global impact.

The Biosecurity Training Centre will be aligned to the Faculty of Science and Health, operating as a unit aligned to the School of Agricultural, Environmental and Veterinary Sciences. The School of Agricultural, Environmental and Veterinary Sciences provides more than twenty undergraduate and postgraduate courses within the Faculty of Science and Health. This includes Agricultural Science, Agribusiness Animal Science, Environmental Science and Management and Veterinary Science. The School has substantial infrastructure of a high standard for training veterinary undergraduates and postgraduates, including access to on-campus veterinary enterprises in Wagga. The School has a strong research profile, including significant numbers of undergraduate honours and higher research degree students. Relevant research strengths include animal health, welfare and diseases, epidemiology, biosecurity, toxicology, animal models of human conditions and animal production.

Charles Sturt University is a national leader in biosecurity, with extensive capabilities that align directly with the Commonwealth Government's broader Ag2030 targets, including those outlined in the Biosecurity 2030 Strategic Roadmap.


Charles Sturt University has been successfully awarded the contract to partner with the Commonwealth Department of Agriculture, Fisheries and Forestry (DAFF) to establish and deliver a Biosecurity Training Centre (BTC). Charles Sturt and DAFF will work to achieve the strategic objective of building a highly competent and capable national biosecurity workforce and to become the leading training provider and Centre of Excellence in biosecurity education, innovation and research for the Asia Pacific region.

The initial role of the BTC will be in the development and delivery of the Biosecurity Foundation Program for frontline Biosecurity Officers within DAFF, with a longer-term goal of developing and delivering new training programs, informed but impactful research, and engaging industry and near-neighbour partners in the training offerings as well.

Position overview

The purpose of this role is to provide business and operational management in the conduct of the Biosecurity Training Centre that Charles Sturt is co-delivering with the Commonwealth Department of Agriculture, Fisheries and Forestry (DAFF) (previously Department of Agriculture, Water and the Environment (DAWE)).

Working directly with the Charles Sturt Academic Director of the BTC, the Business Manager will be responsible for the management, coordination and direction of the BTC's administrative and financial functions. The incumbent will be responsible for ensuring that the BTC's operations demonstrate sound practice and process and that they are compliant with the overarching contract and University rules, policies and processes, where applicable to BTC activities. The position has advisory and management responsibilities with respect to the BTC budget and with respect to business management of the Centre and staff.

The Business Manager will also prepare for and contribute to relevant BTC committees as required per the contract.

Principal responsibilities

- Manage the Charles Sturt operations of the Biosecurity Training Centre, including budget and staff management to ensure contract deliverables are met.
- Work with the Charles Sturt Partnerships team to manage the BTC contract and ensure compliance and services meet the needs of the partner.
- Provide advice to the BTC Operational Management Committee regarding the activities of the Centre as per reporting requirements within the contract, including student records, completion reports and so on.
- Prepare reports and other relevant documentation for the BTC Operational Management Committee and attend as a committee member.
- Coordinate required activities with relevant Charles Sturt teams and divisions to ensure client expectations are met and that a high-level of customer service is provided.
- Coordinate subcontractor and service provider contracts, e.g. experienced VET providers, to
 ensure delivery of high-quality vocational courses and outcomes, as/if required.
- Ensure efficient and effective student enrolment systems and processes are developed.
- Oversee the development of thorough evaluation for BTC activities and education delivery.
- Other duties appropriate to the classification as required.

- E. Excellent written, oral, and visual communication skills and high quality analytical skills.
