# **POSITION PURPOSE**

A Level C research-only academic is expected to make independent or original contributions to the research effort within their field of expertise and to the organisational unit or inter-disciplinary area of which they are a part. An academic at this level is expected to play a major role in research including the exercise of some leadership in research.

In the Faculty of Education, Peninsula campus, the first National Programmatic Study of early childhood science, engineering and technologies has been established.

This position is part of a team of 3 Senior Research Fellows, 6 PhD students, and a Research Officer who will work over five years on the programmatic study aimed to research conceptual play by examining imagination in play and imagination in science, engineering and technology.

## **KEY RESPONSIBILITIES**

Specific duties required of a Level C research-only academic may include:

- 1. The conduct of research and the writing of research papers in high impact journals and the presentations of research at conferences directly related to the goals of the Laureate fellowship
- 2. Supervision, where appropriate, of post-graduate HDR students
- **3.** Involvement, where appropriate, in the promotion of research links with outside bodies directly related to the goals of the Laureate fellowship
- **4.** Preparation of research proposal submissions to external funding bodies directly related to the goals of the Laureate fellowship
- 5. Responsibility for the oversight of financial management of grants received for their research projects
- **6.** Significant role in research projects including, where appropriate, leadership of research teams or management of projects
- 7. Involvement in professional activities including, subject to availability of funds, attendance at conferences and seminars directly related to the goals of the Laureate fellowship
- 8. Supervision of postgraduate research projects related to the programmatic research
- 9. Various research-related administrative functions
- **10.** Attendance at meetings associated with research or the work of the organisational unit to which the research is connected and a major role in planning and associated with the goals of the Laureate fellowship

#### **KEY SELECTION CRITERIA**

## **Education/Qualifications**

- 1. The appointee will have:
  - A doctoral qualification in the relevant discipline area or equivalent accreditation and standing together
    with subsequent research experience associated with young children (preferably infants, toddlers or preschoolers)

#### **Knowledge and Skills**

- 2. Demonstrated ability to write independently for high quality journals, with an emerging record of publications, conference papers, reports and/or professional and/or technical contributions in the relevant discipline
- **3.** The ability to work independently in a research environment and as part of an inter-disciplinary research team
- **4.** High level organisational skills, including the ability to plan and manage the use of research funds, with demonstrated capacity to establish and achieve goals

- **5.** Excellent written and oral communication skills including the ability to prepare and communicate the aims and outputs of research projects in a range of formats
- 6. A demonstrated capacity to work in a collegiate manner with other staff in the workplace
- **7.** High-level of understanding, or willingness to work with and learn about the theoretical research concepts underpinning the programmatic study (cultural-historical theory)
- **8.** Experience with and demonstrated expertise in researching in play-based setting with young children or researching in families or other informal environments
- **9.** Experience and expertise in digital visual methodologies or similar observational approaches and/or quantitative research
