Position Context/Purpose

The **Network Engineer** at La Trobe University is a pivotal technical role responsible for the design, implementation, and maintenance of the university's **Cisco network infrastructure**. Reporting to the Network Infrastructure Manager, this position contributes significantly to the reliability, scalability, and performance of the network, employing industry best practices and advanced technical expertise in a Cisco environment. A **Cisco certification** would be highly desirable for this role, further demonstrating expertise in managing Cisco systems.

The Network Engineer also plays a crucial role in driving network innovation, strategic planning, and coordination to ensure alignment with university objectives and industry standards. Additionally, this position is part of the **on-call roster**, requiring the engineer to be available for addressing urgent network issues and ensuring continuous uptime.

Duties at this level will include:

Network Design and Implementation

- Being involved with the design and implementation of Cisco network solutions, including routers, switches, and other network devices, to meet the university's requirements and industry standards.
- Configure and deploy Cisco networking technologies, such as Cisco Catalyst switches, ISR routers, and Nexus data centre switches, ensuring optimal performance and reliability.

Network Optimisation and Performance Management

- Proactively monitor and optimise the performance of the Cisco network infrastructure, leveraging Cisco IOS, IOS-XE, and NX-OS platforms to identify and address performance bottlenecks and issues.
- Utilise Cisco network monitoring tools, such as Cisco DNA Centre, Cisco Spaces to gather performance data, analyse trends, and implement optimisations for enhanced network efficiency.

Collaboration

- Collaborate with cross-functional teams, including IT operations, security, and applications, to integrate Cisco network solutions and support university initiatives.

Technical Expertise and Innovation

- Stay abreast of emerging Cisco technologies and industry trends, such as Cisco Software-Defined Networking (SDN), intent-based networking (IBN), and network automation, to drive innovation and continuous improvement in the Cisco network environment.
- Provide expert technical guidance and recommendations to enhance Cisco network architecture, security posture, and operational efficiency.

Documentation and Knowledge Sharing

- Maintain comprehensive documentation of Cisco network configurations, topologies, and operational procedures, ensuring accuracy and accessibility for team members and stakeholders.
- Share knowledge and best practices with colleagues, fostering a culture of continuous learning and improvement in Cisco network operations and management.

Essential Criteria

Skills and knowledge required for the position

- Advanced knowledge of Cisco network architecture principles, routing and switching protocols (e.g., OSPF, BGP), and Cisco IOS software.

- Proficiency in configuring and managing Cisco networking technologies, including Cisco Catalyst switches, ISR routers, Nexus data centre switches, and Cisco wireless solutions.
- Experience with Cisco network monitoring and management tools, such as Cisco Spaces, Cisco DNA Centre, and Cisco Identity Services Engine (ISE), is desirable.
- Cisco certification (such as CCNA, CCNP, or equivalent) would be highly desirable.
- Excellent communication and interpersonal skills, with the ability to collaborate effectively with technical and non-technical stakeholders.
- Strong problem-solving and analytical skills, with a focus on delivering practical solutions to complex Cisco network challenges.
- Commitment to professional development and continuous learning in the field of Cisco networking and information technology.
- An undergraduate degree in any area relevant to the position with at least 4 years subsequent experience; or extensive experience and management expertise; or an equivalent alternate combination of relevant knowledge, training and/or experience.

Capabilities required to be successful in the position

- Expertise in Cisco network design, implementation, and optimisation to ensure the reliability, scalability, and performance of the university's network infrastructure.
- Collaboration and teamwork to work effectively with cross-functional teams and contribute to university-wide initiatives in Cisco networking.
- Innovation and creativity to explore new Cisco technologies and solutions that enhance network performance, security, and agility.
- Communication and knowledge sharing to document Cisco network designs, troubleshoot issues, and share expertise with colleagues and stakeholders.
- Adaptability and resilience to thrive in a dynamic and evolving Cisco network environment, with a focus on delivering high-quality results and customer satisfaction aligned with industry standards.
- Willingness and availability to participate in an **on-call roster**, providing out-of-hours support when necessary to maintain the stability and security of the network.
- Have valid Victorian Driving license and willingness to travel for Latrobe campuses within Victoria (Bundoora, Bendigo, Shepperton, Albury-Wodonga, Mildura).
