ROLE SPECIFICATION

Summary of the broad purpose of the role in relation to the organisation's goals

The Direct Care Worker (Residential) will assist in providing a direct client service to residents of the Residential Care Home.

Reporting/Working Relationships

The Direct Care Worker (Residential) is accountable to the General Services Supervisor and works in close collaboration with health professionals and is part of a multi-disciplinary team.

Handling of Official Information

By virtue of their duties, SA Health employees frequently access, otherwise deal with, and/or are aware of, information that needs to be treated as confidential.

SA Health employees will not access or attempt to access official information, including confidential patient information other than in connection with the performance by them of their duties and/or as authorised.

> Prescribed positions under the Disability Services Act 1993 must obtain a satisfactory Disability Services Employment Screening through the Department of Human Services (DHS) Screening Unit

> NPCs and DHS Disability Services Employment Screenings must be renewed every 3 years thereafter from date of issue.

> WWCCs must be renewed every 5 years thereafter from date of issue.

> The position is primarily located at Gumeracha but the incumbent maybe required to work from other sites within BHFLHN.

> Must be an Australian Resident or hold a current working visa.

> Current driver's license and willingness to drive.

> Appointment is subject to immunisation risk category requirements (see page 1). There may be ongoing immunisation requirements that must be met.
