Role purpose

Transport Volunteer Drivers are responsible for the safe and courteous vehicle transportation of the frail and/or disabled people in our community to attend medical appointments and social engagements, who are socially isolated, transport disadvantaged and have no other means of suitable transport.

Role responsibilities

- Driving a Red Cross Transport Vehicle, pick up and transport clients to their appointments/engagements in accordance with a daily run schedule.
- Provide customer service - ensure a safe and courteous on board environment; maintain confidentiality' assist clients with lightweight walking aides (walking sticks, frames, crutches etc.)
- Record and maintain a log of activities including distance travelled, fees and donations.
- Maintain cleanliness and presentation of the vehicle and ensure the vehicle is refuelled at the end of the day and is operating safely.
- Maintain contact with the Coordinator regarding any concerns or issues related to the program or any concerns regarding a client in accordance with information sharing guidelines.
- Participate in required training and evaluation activities.
- Adhere to all Red Cross and Transport Policies and Procedures.

Knowledge, skills and experience

- Genuine interest in the well-being of people.
- Full Drivers Licence and understanding of the Tasmanian Road rules
- Show empathy for the mature aged, disadvantaged and socially isolated clients
- At ease working independently or as part of a team to share the workload

Check requirements

- A National Criminal History Check prior to commencement and renewed every three years (Red Cross will arrange this)
- Evidence of up to date* vaccination against COVID-19 is a mandatory requirement for this role. *As per latest definitions by the Australian Technical Advisory Group on Immunisation (ATAGI), or who have a medical exemption based on ATAGI guidelines

Learning and development

- Complete Red Cross online learning modules as required
- Attend Red Cross Volunteer Induction, Program Training and ongoing training as required
- Attend scheduled volunteer meetings

General conditions

We are a Child Safe organisation and all volunteers are required to comply with relevant State and Territory legislation requirements

We comply with the Red Cross Workplace Health and Safety management system

We may be required to assist the organisation on occasion, in times of national, state or local emergencies or major disasters
