### Your work area

The Rural Clinical School of Western Australia (RCSWA) is a network of 15 rural and remote sites across the Kimberley, Pilbara, Mid-West, Goldfields, Great Southern and South West regions of Western Australia. It is a collaboration between UWA, The University of Notre Dame Australia, Fremantle and Curtin Medical School, operating as a unit within the UWA School of Medicine. The RCSWA is committed to providing quality teaching, research, professional development and clinical service in rural and remote settings.

#### Your role

The Medical Coordinator's (MCs) main responsibility is to assist with organising and teaching of RCSWA students. MCs can also be supported to develop in other academic areas (research, service, further clinical skills) depending on their interests.

## Your key responsibilities

- In consultation with local medical practitioners and agencies maintain and further develop local educational programs that meet the requirements of the RCSWA and take advantage of local opportunities and strengths.
- 2. Deliver medical education and training to medical students and assist in the support of preceptors and host practitioners.
- 3. Arrange learning opportunities for medical students by liaising with local agencies.
- 4. Where possible, be involved in research and/or evaluation relevant to improving rural health.
- 5. Develop and coordinate the development of rural training pathways in local area of appointment and contribute to a statewide RCSWA approach.
- 6. Other duties as required.

- 1. Registered, or able to be registered with AHPRA as a Medical Practitioner.
- 2. Committed to working in medical practice in rural WA

- 3. Available to work in the respective RCSWA site and the ability to network with rural practitioners in the region.
- 4. Experience as a preceptor and/or supervisor of medical students and/or junior doctors or registrars.
- 5. Effective organisational, communication and negotiation skills.
- 6. A commitment to the principles and practice of Indigenous health in rural and regional areas.
- 7. Practice medicine in rural WA
- 8. A commitment to rural medical education and to improving rural medical workforce.

#### **Desirable**

- 1. Registered as a specialist (GP or other specialty) with AHPRA.
- 2. Experience in medical education including knowledge of the medical curriculum of UWA or UNDA.
- 3. Currently resident and practicing in the town applied for.
- 4. Experience in career mentoring for students and/or doctors in rural settings
- 5. Experience in Indigenous health.
- 6. An interest in research in and into rural health
