Co-ordinate and manage relevant evaluation sub-studies and other related research

Disseminate evaluation, sub-studies and related research findings through presentations at appropriate conferences and other fora and through publications in appropriate peer-reviewed journals and other reports.

Undertake research management administrative work in support of the evaluation, sub-studies and related research

Develop applications for future funding as appropriate

Manage their own workload and determine work schedules and priorities within parameters set by the supervisor and Ruah Community Services' Research and Evaluation Team.
