KEY RESPONSIBILITIES

A Teaching Associate works with the support, guidance and/or direction from the relevant Chief Examiner(s).

Depending on qualifications and experience, the Teaching Associate's academic duties include:

1. The preparation and delivery lectures and tutorials, seminars and/or workshops
2. Ensuring the security and confidentiality of teaching, examination materials and student results

3. Production/adaptation of appropriate teaching materials (N.B. preparation time is implicit in the calculations of Teaching Associate remuneration) with appropriate guidance from the Chief Examiner
4. Comply with Monash University policy on Equity and Diversity to ensure that all students are treated with respect and dignity in an environment in which a diversity of backgrounds and experience is valued
5. Contributing to and participation in quality assurance initiatives, as appropriate
6. Contributing to unit and/or course and team planning review processes through attendance at team meetings
7. Maintaining records (teaching and student related) as required
8. Working collaboratively with colleagues across the Department
9. Marking and assessment primarily connected with the units in which the Teaching Associate is engaged
10. Consultation with students

KEY SELECTION CRITERIA

Essential

1. A Teaching Associate will have completed study in the relevant discipline, at least to Honours Level, or have equivalent industry experience
2. Possess a high-level of interpersonal skills and demonstrated ability to work independently and as part of a team
3. Ability to work positively and cooperatively with students
4. Demonstrated ability to stimulate, actively engage and educate a given audience

Desirable

5. Significant progress towards completion of a PhD in Finance
6. Current practical experience within an industry related to the discipline
7. Previous teaching experience in a tertiary environment
8. Capacity to develop and deliver unit material
9. Capacity and commitment to contribute to flexible modes of academic program development and delivery
10. Experience in designing units and teaching materials

Appointment

Sessional Teaching Associates are appointed for a period of up to 12 months, covering the academic year.

Payment
