- Lead and coordinate periodic asset condition assessments, including developing scopes of work
 for the procurement of contractors / consultants, overseeing engagements ensuring alignment
 with mater policies and procedures, and reviewing subsequent asset condition reports.
- Work with Mater Business Units to improve asset data capture and financial analysis.
- Utilise data to make informed decisions about the performance, risk and reliability of assets, and their impacts on spend against budget.
- Provide input into Engineering & Maintenance in relation to the development of long-term planned maintenance forecasts.

Operational and Financial Management

- Interface with Engineering, DTI, Capital Works and Finance to ensure asset depreciation and replacement value is captured in an accurate and timely way that reflects stakeholder requirements.
- Participate and feedback in the asset management lifecycle, asset register, asset related risk, and asset management systems and processes.
- Adopt a continuous improvement approach and instil best practice asset management practices into business-as-usual.
- Stay informed of industry best practice, emerging technologies and legislative requirements related to asset management.
- Participate in the development of service level agreements and develop a series of performance indicators to measure successful delivery of asset management in the organisation. Generate appropriate reporting to relevant Governance Committees within Mater.
- Lead the development of the annual Investment Plan for Development & Infrastructure in accordance with the framework.
- Utilise / improve asset management prioritisation scoring model to inform the annual Investment Plan and future years' planning.
- Participate in the sourcing, negotiation and review of centralised Standing Offer Arrangements and Contracts for property related contracts to drive value for Mater.
- Work with key Mater stakeholders in the assessment of strategic property acquisitions including condition assessments.
- Develop and contribute to policies, guidelines and procedures relating to asset management where required.
