Position Summary

We are seeking to appoint up to five (5) Lecturer and/or Senior Lecturer positions in the <u>Faculty of Law</u> within the <u>College of Arts, Law, and Education</u>. The Faculty of Law, one of Australia's premier law schools, has a long and distinguished history and strong reputation nationally and internationally for high quality research and success with competitive grant funding. The Faculty also has a number of staff and programs recognised nationally for excellence in teaching. With strong engagement with the community, it supports and helps to shape the law reform agenda through hosting the Tasmanian Law Reform Institute.

The Faculty seeks to promote a broad-based student experience, with an internationalised curriculum, including exposure to and opportunity to participate in social justice and community service activities. We are seeking persons who have the demonstrated ability to teach (including capability in digital pedagogy) in one or more of the following areas:

- Evidence / Procedure
- Private Law (Contract, Torts, Equity & Trusts, Property)
- Commercial Law (including Corporations Law)
- Criminal Law.

Personal qualities of collegiality and high levels of engagement are expected.

Teaching includes scholarly course design and development, delivery in face-to-face and blended-modes, and assessment in law courses, in collaboration with other staff within the Faculty and University.

- A PhD or equivalent in a relevant field.
- A good record of, and continuing commitment to, research that has achieved national recognition and made worthwhile contributions to the field of Law, demonstrated by quality publications, presentations at conferences and, preferably, success in securing external competitive and other funding.
- Demonstrated ability to deliver and coordinate dynamic and relevant learning experiences for students at undergraduate and/or higher levels, using contemporary teaching practices, delivery modes and technologies, in one or more of the areas listed above.
- A record of contributing to building and maintaining effective and productive links locally and nationally with the discipline, profession, industry and wider community.
- Excellent oral and written communication skills and capability to build strong and positive relationships with colleagues, students, and external stakeholders.
- Clinical/industry/professional experience relevant to the position is desirable.

- Travel between campuses may be required to deliver teaching and learning outcomes.
