Role purpose

The Police Call Outs program provides suitably trained volunteers to be present with a young person (defined as aged 10 to 17 years) whilst they are held in police custody (e.g. when being interviewed by South Australian Police in the instance where a parent or guardian is unavailable). The volunteer is an objective observer of the interview process and seeks to ensure due process is followed.

- The program provides support for young people who are:
- Under the age of 18 years;
- Do not have a family member or appropriate adult support; or
- Do not have a Youth Justice Representative or appropriate Case Manager available to attend.
- Under the Guardianship of the Minister

Role responsibilities

- Commit to a roster to provide support and assistance to young people between the ages of 10 and 17 years who are apprehended by police;
- Make sure the young person understands your role as a volunteer and why you are there to support them:
- Be prepared to respond to Police Call Outs at a local police station within 90 minutes;
- Provide information and as applicable, refer young people to appropriate support services using procedures developed by the program;
- Provide the young person with information about what processes may be followed whilst they are being questioned and assist them to understand their rights and responsibilities in the process;
- Assist with communication between the police and the young person and clarify any ambiguities;
- Encourage the interview process to respect the rights of the young person;
- Inform the Project Officer in a timely manner of any issues;
- Complete the Police Call Outs Attendance and Feedback Form promptly and accurately and return to the Project Officer;
- Attend training sessions and induction as required;
- Participate in the ongoing improvement of the program.

Knowledge, skills and experience

- Highly developed communication and organisation skills;
- Understanding of issues affecting young people from a diverse range of backgrounds and environments;
- Effective interpersonal skills and ability to develop good rapport with young people;
- Ability to work within the Police Call Outs program guidelines and adhere to all policies and principles of Red Cross;
- Willingness to attend rostered police stations;
- Demonstrated ability to respond appropriately to difficult situations;
- Commitment to volunteer a minimum of three shifts per month for a minimum of six months;
- Understanding of and commitment to social justice principles;
- An understanding of the youth justice sector (desirable);
- Knowledge of local youth support services (desirable).

Check requirements

- Current Australian Driver's License
- A National Criminal History Check and SA Working with Children's Check prior to commencement
- Child Safe Environments Training is required

Learning and development

- Complete Red Cross online learning modules as required
- Attend Red Cross Volunteer Induction, Program Training and ongoing training as required
- Attend scheduled volunteer meetings, a minimum of two per year

General conditions
