Compassion – consistently acting with empathy and integrity

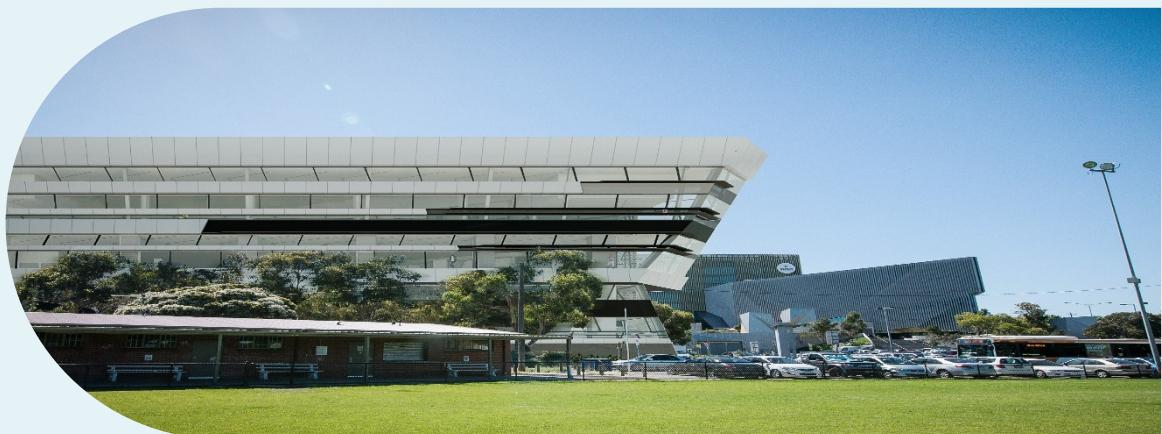

Professor in Nutrition and Dietetics

The Professor of Nutrition and Dietetics will be a joint position between the Nutrition Department, Western Health and the School of Exercise and Nutrition Sciences, Deakin University. The School of Exercise and Nutrition Sciences has an established Dietetics Clinical School with Western Health, which enables a professional and joint working relationship to support education of dietetics students, joint research activities and input from the profession into our dietetic education programs.

The purpose of this position is to provide academic and professional leadership to clinical and academic staff and students of the respective institutions, appropriate to the research focus and clinical priorities of the partners. The Professor will provide outstanding academic and research leadership in the area of nutrition and dietetics and allied health research at Western Health and will foster links between academics and practitioners, and facilitate development of collaborative research to address practice-based evidence gaps. The appointee will initiate and contribute to School and Faculty teaching, research and program

development and entrepreneurial activity and promote the School within relevant academic and professional communities in Australia and internationally. The appointee will contribute to service activities locally and internationally particularly in relation to student recruitment and will champion the strategic directions of the School, the Faculty and the University.

In terms of the key areas of research focus, the School of Exercise and Nutrition Sciences and Western Health currently have shared interests in the treatment and management of cardiovascular disease, type 2 diabetes and related metabolic conditions, cancer/oncology, and malnutrition, and demonstrating the impact of dietetics services. Future research opportunities include:

- Collaboration with other professorial researchers in Allied Health, medicine, nursing and midwifery
- Along with other Allied Health research leads, to build research capability in nutrition and allied health including development of clinician-researchers, research higher degree students, and clinicians as consumers of research
- Involvement in multi-site research building on professional

networks with other major metropolitan health services.

- Evaluation of innovative nutrition service models in both the inpatient and outpatient settings
- Development and evaluation of pathways for nutrition support interventions
- Research in the Food Service setting with new and existing new food service systems and services.

TEACHING AND RESEARCH LEVEL E

- Advising and supporting the development of students regarding teaching and learning
- Actively participating in postgraduate education and learning on an as needs basis at the request of the Head of School.

ORGANISATIONAL CONTEXT

The appointee will form part of the research and teaching team within the School of Exercise and Nutrition Sciences, which is one of five Schools in the Faculty of Health. Staff within the School report to the Executive Dean through the Head of School.

Specifically the appointee will provide leadership, and coordinate and support Allied Health staff and students at Western Health, and Deakin University in research, teaching and clinical activities that are relevant to the partnership and university objectives. She/he will be expected to conduct research, seek external research and commercial funding and build cooperative relationships with industry partners and other external groups.

The Directorate of Community Integration, Allied Health and Service Planning at Western Health consists of a range of community based and allied health services. Western Health employs a range of allied health disciplines, each with unique specialist tertiary training and skills to provide a range of services and programs

that deliver high quality, multidisciplinary care across acute, subacute and community program areas.
