The Rural Generalist Physiotherapist applies clinical experience, increasingly generalist and / or specialist clinical knowledge and professional competence to plan, implement and evaluate a comprehensive and integrated range of services, appropriate to the needs of the Limestone Coast community. The Rural Generalist Physiotherapist works under reduced clinical direction, and may contribute to the clinical supervision of less experienced allied health professionals, Allied Health Assistants and students. As a member of multi-professional teams, including health professionals and service providers from other sectors, the Rural Generalist Physiotherapist utilises a combination of preventative, early intervention, treatment / therapy and evaluation approaches. The Rural Generalist Physiotherapist may be required to work within Subacute services, in which case the Physiotherapist will adopt a rehabilitative approach to service provision, as defined in the *Statewide Rehabilitation Clinical Network Rehabilitation Generic Core Competencies Framework*. Services will focus on improving health outcomes, functional capacity and quality of life, in accordance with clinical guidelines and models of care.
