Advanced training to the level of a dental specialist in Dento-maxillofacial Radiology

Specialist dental qualification registrable with the Dental Board of Australia without limitations in the specialty of "Dento-maxillofacial radiology."

Extensive knowledge, clinical experience, skills and judgement in the practice of Dento-maxillofacial Radiology

Demonstrated excellence and leadership in dental research, with a significant impact in the field of expertise.

Ability to successfully establish relationships and to effectively collaborate with the dental/medical or other relevant industry, such as through consultancies or grants

Current or recent clinical practice as dental specialist in Dento-maxillofacial Radiology with a clear understanding of the clinical environment

Ability to design and deliver continuing professional development programs for dental/medical personnel

Peer recognition in the form of fellowships from international academies and colleges, and/or invited presentations at international meetings

Ability to successfully establish relationships and to effectively collaborate with dental and other relevant industry.

Clinical experience across a range of settings in private, hospital and university environments
