■ Position Summary

Australian Red Cross' Migration Support Programs (MSP) works to assist migrants in transition to ensure they have their humanitarian needs met and are participating and included in Australian society. Australian Red Cross also works to directly contribute to the Red Cross Red Crescent Movement's increased impact on migration.

In Search of Safety is a community education program that engages the Australian public in conversations related to forced migration. This position will work alongside Red Cross staff and volunteers to present interactive workshops that talk with school students and community groups about the asylum seeker journey and the reasons why people seek protection in Australia, whilst promoting compassion, harmony and social cohesion in line with Red Cross Strategy 2022.

The primary role of Lived Experience Community Speakers is to share their experience of seeking asylum and living in Australia to increase understanding and promote connection.

Key Responsibilities

- Attend presentations to share personal lived experience (mostly at schools)
- Attend any relevant training
- Respond to questions about seeking asylum and life in Australia during the presentation
- Encourage students / community members to interact positively and meaningfully during the presentation
- Contribute to program evaluation.

Qualifications/Licenses

- Positions are available for people granted an Australian permanent protection visa; Temporary Protection Visa (TPV) or Safe Haven Enterprise Visa (SHEV); OR arrived in Australia on another visa but have a refugee background. Those in the process of seeking asylum will also be considered
- A Working with Children check is a mandatory requirement for this role.

- Demonstrate skill, knowledge and behaviour to work with Aboriginal and Torres Strait Islander people in a culturally respectful way
- Comply with the Work Health and Safety management system
- Undertake a police check prior to commencement and every 5 years thereafter. Police check renewals
 may be required earlier than 5 years in order to comply with specific contractual or legislative
 requirements
- Support a child safe organisation by undertaking screening for suitability to work with children, youth and vulnerable people and to comply with relevant state/territory legislative requirements
- Assist the organisation on occasion, in times of national, state or local emergencies or major disasters
