The Community Mental Health Practitioner - Peer Practitioner is expected to be a champion of co-design and co-production in all aspects of the service, work with clients to define their own outcomes and deliver personalised support services and recovery-oriented care to people living with mental ill health in the community.  Peer support is an important part of Mind's approach to recovery. The Peer Practitioner works as part of a multidisciplinary team with lived experience of mental ill health and recovery being the unique specialist lens that they bring. |  |

| About the service         | Youth Residential Rehabilitation Service (YRRS) supports young people between the ages of 16 and 21 who are recovering from a disability associated with a psychiatric condition. Working within a Mind's Model of Recovery Oriented Practice, My Better Life model and organisational values the service provides up to 12 months stay in a safe, home-like therapeutic environment.  The YRRS provides young people intensive individual and group based support that promotes resilience, interpersonal skills, enhanced social connections, life skills, access to the community and a greater sense of being able to make sound decisions including healthy lifestyle choices. Clients benefit from sharing their experiences and recovery journeys with  |  |







|  | the other residents whilst growing their confidence and skills to live independently in the community. The service also delivers a day program for young people recovering from mental health challenges to develop life skills and support to remain in the community.   |  |  |
