Position Purpose:	To provide a safe and caring environment where intoxicated people can be safe and cared for until the period in acute intoxication has passed.

	Provide care to intoxicated clients admitted to the shelter, including but not limited to, completing admission and discharge procedures and evaluating clients to determine whether the shelter is the safest place to sober up.	•	Communicates well with referring services such as NT Police and Night Patrol. Shows compassion, sensitivity and patience when dealing with intoxicated individuals. Portraits Cultural Awareness and sensitivity.



- Providing assistance to these clients as well as cleaning, food preparation, client laundry and making beds.
- Conducting assessments and referrals.
- Advocate on behalf of your clients.
- Provide information about services offered by Mission Australia and other Community Services organisations and Allied Health services.
- Effective resolution of client issues.
- Respecting client rights and confidentiality at all times.
- Maintain and update all records relating to a client's admission, case management and discharge.
- Obtain a Department of Health portal login and maintain and update all records in the portal.
- Report occurrences to Program Manager or via Riskware.
- Undertake administrative tasks as required.
- Maintain the shelter in a clean state.
- Undertake training and professional development as required by Mission Australia.
- Undertake any other reasonable duties as directed by the Shift Supervisor or Program Manager.

- Written documentation and assessments are completed to a high standard.
- Clients are referred to other Community Service Organisations or Allied Health Services where appropriate.
- Report client issues to the Program Manager via email or Riskware as required.
- All client records must be completed before leaving the shelter at the end of a shift.
- Shift Supervisor or Program Manager will obtain Department of Health login and provide adequate training.
- Relevant training in Alcohol and Other Drugs or Community Services is desirable. Training should be completed within 12 months from commencement.

Key Result Area 2

Key tasks

- Provide assistance to Community Corrections participants, students, volunteers and other visitors to the shelter.
- To actively participate and contribute to monthly team meetings, team building and internal/external training activities.
- Work with the larger team and management to ensure the operation of the service and client care is of a high standard within a well-defined safety and services standard.

- Strong interpersonal skills and the ability to communicate, particularly with Aboriginal and Torres Strait Islanders.
- Cultural Awareness.
- Conflict resolution skills.
- Ability to work independently, use initiative and problem solving techniques to achieve workplace solutions.
- Able to work a constantly evolving roster covering extended hours Monday to Saturday.
- Proven experience with computer programs particularly the Microsoft Office Suite.
